PURPOSE: To authorize the Chief Administrative Officer (CAO), for and on behalf of the City of Richmond, to accept funds in the total amount of \$131,910.31 from the City's insurance carrier, AIG/Lexington Inc. Commercial Property Casualty and to appropriate the increase to the Fiscal Year 2016-2017 Capital Improvement Program Budget Facilities Management Major Buildings line item for the purpose of capital improvements to the roof at Fleet Management Building at 1700 Commerce Road.

REASON: To accept and appropriate \$131,910.31 received from the AIG/Lexington Inc. Commercial Property Casualty.

RECOMMENDATION: The Department of Public Works recommends approval of this ordinance.

BACKGROUND:

On May 9, 2014 severe winds damaged the roof at the Fleet Management Complex-1700 Commerce Road. The roofing contractor observed asbestos in the roof tiles and a claim was submitted on July 17, 2014 to AIG/Lexington Inc. Commercial Property Casualty, the City's insurance carrier.

The property insurer has reimbursed the City for \$131,910.31 for property damage sustained during a 2014 storm event that damaged the roof of the fleet maintenance garage. Loss for the wind damage claim to 1700 Commerce Rd with the updated costs for the asbestos abatement, testing, and roof replacement. The roof replacement cost is \$385,507.96.


