Hi Mr. Dealaman,

I wanted to have the following comments added in opposition of the Special Use Permit Request for additional attachments for 2202 N 28th Street and 2704 Selden Street. As a tax paying homeowner residing in property abutting to one of these lots and a couple houses from the other, I would like to see the current R-5 zoning remain in place. I am very concerned about having this proposal move forward for the reasons below.

1. **Parking** - The additional attachments would create 2 additional houses in my block than what is currently permitted in the R-5 zoning. This would create limited access for parking in this block.
2. **Privacy** -The additional attachment would create 2 additional story homes in height. I live in a 1 story rancher and the additional height would create 2 more additional neighbors than what currently permitted in the R-5 zoning. This will reduce privacy and enjoyment in my property.
3. **Single Family Dwelling** - Most homes in the block are single story ranchers dwellings. I would like to see any new homes built on this block remain as a single story dwellings.
