Dear Honorable Members of City Council,

I'm writing in support of RES. 2024-R011 which is currently on the consent agenda for this coming Monday's meeting, following the recommendation from the Land Use, Housing, and Transportation Committee this week.

I'm a resident of the 1st District and joined the Path to Equity transit committee as a citizen ambassador three years ago, transitioning into an ambassador for Richmond Connects' planning. It has overwhelmingly been a positive experience and stands out to me as an example of good local government.

The City's team did an excellent job, along with its outside consulting partners, of building an engagement plan that allowed resident input on everything from the principles of the Path to Equity to the practical nature of the strategic framework that is Richmond Connects and specific transit issues in every district that need to be addressed. Participating in the workshops, I witnessed the issues our city faces with basic daily transit needs and a plethora of recommended solutions. I think the average resident is used to a slow-moving government where change never quite meets current needs, so it was especially encouraging to witness "tactical urbanism" as quick-fix, low-budget solutions to be tested, and not put every need in long-term budget plans. As the city builds its engagement for Participatory Budgeting I think this work by Richmond Connects will prove especially helpful.

The strategic plan successfully provides a framework for the priorities to create a safe, equitable, and sustainable transportation system for all residents. We have much work to do but I believe your approval of this plan will help ensure we create a better Richmond. We have three young children in my family so attending City Council meetings in person can be a challenge, and I ask you to accept my written endorsement in place of attendance. I am hopeful you will see a strong crowd of transit advocates speaking positively of their experiences on this planning cycle as well.
