## **Charitable Grant Funding Background**

- Competitive charitable grants provide one-year funding subject to appropriation to eligible charitable organizations to address unmet, critical needs in the City of Richmond.
- Grants to awardees are made as invoice-based reimbursements based on contracts between the grantee and the City of Richmond.
- The three priority funding areas include:
  - Children, Youth, and Education
  - Housing, Human Services, and Health
  - Arts and Culture



### Applicants must provide:

- Narrative Non-Departmental Application
- Overall Project Budget
- Previous Fiscal Year Audit or Financial Statements
- Current Year Operating Budget
- List of Board of Directors, Members, and Executive Officers
- Federal Tax Exempt Certification
- Latest IRS 990 Report




### Applicants must meet the following criteria:

- Federally approved non-profit certification
- In compliance with federal, state, and local regulations
- No outstanding violations, taxes, or penalties
- Must have a currently active Board
- Agrees to coordinate its projects with the appropriate groups and Departments
- Must disclose any past or pending lawsuits
