#### AN ORDINANCE No. 2015-206

To amend City Code § 46.1-51, concerning permit issuance to engage in or conduct a certain business, enterprise or activity, for the purpose of removing the fee for the exception that a tank may be abandoned if empty and increasing the fee for filling or removing residential heating oil tanks of less than 1,100 gallon size, and to amend City Code § 46.1-53, concerning the removal and closure of underground storage tanks, for the purpose of removing the exception that a tank may be abandoned if empty and to require soil testing to determine the contents of the tank.

## THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 46.1-51 of the Code of City of Richmond (2004) be and is hereby amended and reordained as follows:

## Sec. 46.1-51. Permit issuance.

Whenever any provision of this chapter or the Virginia Statewide Fire Prevention Code requires the issuance of a permit as a condition precedent to engaging in or conducting any business, enterprise or activity, no such permit shall be issued unless the applicant therefore pays to the city a fee of \$35.00 to defray the cost incident to the issuance of the permit; provided,

§ 2. That section 46.1-53 of the Code of the City of Richmond (2004) be and is hereby amended and reordained as follows:


## Sec. 46.1-53. Underground storage tank removal/closure.

Any underground storage tank that has been used for the storage of combustible or flammable liquids, other hazardous or unknown substance, and is determined to be leaking, abandoned, or not actively used for more than one year shall be removed or filled with [eement] an approved inert solid. A sample of soil near the area under an underground tank shall be tested for tank contents, and a copy of that report shall be provided to the fire code official. A permit from the fire code official is required. The fire code official has authority to decide if tank may be filled with a material or shall be removed. [Exception: Residential heating oil tanks may be abandoned empty in accordance with the Virginia Statewide Fire Prevention Code.] Septic tanks are not covered by this Code.

§ 3. This ordinance shall be in force and effect upon adoption.

PURPOSE: Update city code to meet state fire code about underground storage tank closures.

REASON: Current city code section 46.1-53 was based upon state fire code which then allowed some underground tanks to be abandoned empty. The state fire code had previously required tanks to be removed or filled with an approved inert solid, and years after we amended city code, again state fire code changed so no longer allows abandoning empty. Recommend amend city fire code to align with state fire code by deleting exception allowing abandoned tank empty, and changing specifying fill with "cement" to "an approved inert solid". Also change in Table 46.1-51 noting permit fee \$35 when removing residential above ground heating oil tank.

**RECOMMENDATION:** Amend Section 46.1-53 to the City Code to delete the word "cement" and the sentence about exception allowing tank may be abandoned empty, and add requirement for soil test and fire official has authority to decide if tank may be filled with a material or shall be removed:

"Any underground storage tank that has been used for the storage of combustible or flammable liquids, other hazardous or unknown substance, and is determined to be leaking, abandoned, or not actively used for more than one year shall be removed or filled with an approved inert solid. A sample of soil near area under an underground tank shall be tested for tank contents, and a copy of that report provided to the fire official. A permit from the fire code offi-

cial is required. The fire official has authority to decide if tank may be filled with a material or shall be removed. Septic tanks are not covered by this Code."

Modify in Table 46.1-51 \*\*\* note on fee for Storage Tank closure / removal to read: "\*\*\*Note: \$135 first tank on site, + \$70 each additional tank same site and time; \$45 when another inspection required to complete job beyond original appointed time. Exception: \$45 for approved fill in place of an underground, or removal of above ground, residential heating oil tank of less than 1,100 gallon size."

BACKGROUND: State fire codes change every three years. Current city code section 46.1-53 was based upon a cycle when the state fire code allowed some underground tanks to be abandoned empty. The state fire code had previously required tanks to be removed or filled with an approved inert solid, and after we amended city code, again state fire code edition changed so no longer allows abandoning empty. Years ago, code required underground tank removal unless fire official allowed fill in place, then code changed so customer chose. Environmental concerns main purpose for this in fire code, thus need soil test and to enable fire official better control.
