ORDINANCE/RESOLUTION SUMMARY

This Resolution is to support the option for defendants of Richmond General District Criminal and Traffic Divisions; and Circuit Court Criminal Division to perform community service hours with departments of the City of Richmond to satisfy unpaid fines and costs owed.

BACKGROUND

This Resolution is to support the option for defendants of Richmond General District Criminal and Traffic Divisions; and Circuit Court Criminal Division to perform community service hours with departments of the City of Richmond to satisfy unpaid fines and costs owed.

Community service refers to service that is performed for the benefit of the local community used as an alternative to imprisonment, which may be required in lieu

of, or in addition to a criminal justice sanction, as a method of repaying a debt to society.

Community Service as a form of alternative sentencing can be performed by completing service projects in lieu of paying court fines and fees or restitution when accepted as a form of payment, as probation conditions ordered by the court and post-trial in lieu of jail time.

Defendants who owe fines to the Richmond courts will be offered the opportunity to perform community service as symbolic compensation and restitution to the court and the community in exchange for a prescribed number of hours of community service to compensate the fine amount.

Community Service Participants will perform assignments with City of Richmond Clean Up Campaigns and with the departments of Public Works, Parks and Recreation, to impact a more attractive and cleaner community, to enhance beautification projects by planting and cleaning up excess trash and debris for cleaner streets and parks to enhance neighborhood clean-up projects

Defendants with no history of violent offenses will be offered the opportunity to participate.

Community Service projects will be completed on public property and not on private property.

In accordance with Code of Virginia §19.2-354, a defendant convicted of a traffic infraction or a violation of a criminal law of the Commonwealth of Virginia, to pay a fine, restitution, and costs, after 30 days of sentencing, the court can order the defendant to pay such fine or costs in deferred payments or installments. Provisions of the Code of Virginia §19.2-354 (C) allows an option to any person upon who a fine and costs have been imposed to discharge all or part of the fines or costs by earning credits for the performance of community service work before or after imprisonment.

Through community service, offenders are able to take responsibility for past actions and repair the damage done by serving the community and can receive training, exposure to job opportunities and build their skill level while improving their own livelihood.

It is requested that by July 1, 2015, the City Attorney's Office and the Chief Administrative Officer in coordination with the Commonwealth's Attorney provide a report to direct the procedures, regulations and documents to facilitate the community service work assignments.
