**PURPOSE:** To Authorize the Chief Administrative Officer to accept \$89,927 from the Virginia Department of Mines Mineral & Energy and Virginia Clean Cities for the incremental cost of nine (9) new compressed natural gas (CNG) vehicles, and one (1) vehicle converted to bi-fuel natural gas, purchased and converted since July 2014. The funds (\$89,927) will be appropriated to the Department of Public Utilities, City of Richmond Virginia Renewal Fund Budget 2015 – 2016 (account number: 0801-99001-43317-000000)

**REASON:** State agencies and local governments in the Congestion and Mitigation Air Quality (CMAQ) areas (Richmond is in the CMAQ attainment/maintenance area) may be reimbursed up to an average of \$10,000 for the incremental cost of new alternative fuel vehicles or reasonable aftermarket conversions to alternative fuel. This funding will be used towards the purchase cost of additional vehicles fueled by compressed natural gas.

**RECOMMENDATION:** The City Administration recommends adoption of these funds.

BACKGROUND: The Virginia Department of Mines Mineral and Energy and Virginia Clean Cities have made incentive funding available to local governments including Richmond, to help cover the costs of transitioning to alternative fuel vehicles, which includes compressed natural gas vehicles.

This grant is retroactive for alternative fuel vehicles purchased new or converted since July 2014. The Department of Public Utilities qualifies for this grant because the Department purchased nine (9) new CNG vehicles (dedicated and bi-fuel), and one (1) vehicle converted to bi-fuel CNG during this period.

The Department will receive funding up to \$89,927 from the Virginia Department of Mines Mineral and Energy in their Alternative Fuel Government Fleet Vehicle Incentive program

FISCAL IMPACT / COST: This is an incentive grant to the Department, which is based on purchases already made.

FISCAL IMPLICATIONS: The Department of Public Utilities will utilize the \$89,927 over the next fiscal year to off-set the cost of purchasing additional vehicles fueled by compressed natural gas.

**REPORTING:** Per DMME requirement staff will report on the cost and the volume of the natural gas fuel for the first year of operation or one complete year of operation.
