The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby officially proclaim:

Richmond Sickle Cell Disease Awareness Month

Whereas, The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to declare Sickle Cell Disease to be a life threatening illness that is a clear and present danger to the life, health and happiness of children, women and men living in our community; and

Whereas, Sickle Cell Disease represents a group of inherited blood disorders that can lead to a number of severe and chronic complications, which include intense pain, heart attacks, infections, and significantly reducing an individual's life expectancy to about 40-60 years; and

Whereas, Sickle Cell Disease is the most common genetic blood disease found in the United States of America, affecting as many as 100,000 individuals in our country and millions more worldwide; and

Whereas, Sickle Cell Disease is found to primarily affect people of African ancestry and some of Mediterranean, Hispanic, Indian, and Middle Eastern descent; and

Whereas, Sickle Cell Disease is an hereditary blood disorder that leads to a tendency of red blood cells to, rather than be rounded and move easily through blood vessels, form into abnormally rigid and sticky cells that resemble a crescent shape similar to a curved farmer's tool called a sickle, which can get stuck and block blood flow and oxygen in the body; and

Whereas, Richmond City Council is a strong supporter, champion and advocate of the life, health and safety of all Richmond Residents and the devastating personal losses, costs and consequences to our community as a result of this disease are tragic, profound and far-reaching; and

Whereas, To increase awareness about this dreaded disease, in 1975 the National Association for Sickle Cell Disease began conducting month-long awareness events; and

Whereas, Sickle Cell Disease advocacy in Richmond include the pioneering work and lifelong dedication of Ms. Florence Neal Cooper-Smith who cofounded the Virginia Sickle Cell Anemia Awareness Program at the Virginia Commonwealth University Medical College of Virginia in 1972, and the recent efforts of Ms. Nicole Lea China and her daughter Ms. Jasmine China in creating the Cells of Life: The Jasmine Cares Project;

The Honorable Dwight C. Elected by the Virginia General Assembly in March of 1990 to serve as a Judge for the Richmond Juvenile and Domestic Relations Court, Judge Angela Edwards Roberts became the first woman judge of African American descent to serve in Virginia.

A trailblazing historic figure, Judge Roberts has served 26 years on the bench and has earned a solid reputation for her effective judicial advocacy on behalf of children and families in Virginia and for her outstanding commitment to judicial services.

A constant pioneer and dedicated public servant, in 1982 Judge Roberts became the first woman of African American descent to serve as Assistant Commonwealth's Attorney for Richmond and in 1988 she became the first to serve as Assistant Bar Counsel for the Virginia State Bar.

As further testament to her professional dedication, Judge Roberts serves as an active member of many organizations, which include national, state, local Bar Associations, the National Council of Juvenile and Family Court Judges and the National and Virginia Associations of Women Judges.

A native of Caroline County, Virginia, Judge Roberts earned her Bachelor of Arts Degree in Political Science from Virginia Tech, with honors, and her Juris Doctor (J.D.) from Emory University School of Law.


