**PURPOSE:** To designate the City property located within the area bounded by Dock Street to the north, Great Shiplock Park to the east, the Kanawha Canal to the south and 17th Street to the west as "the Low Line."

**REASON:** As a nod to New York City's "High Line", the term Low Line is inspired by the linear railway park in New York City. The Low Line connects the recently enhanced Great Shiplock Park (GSP) with Richmond's much-loved Canal Walk along the recently completed Virginia Capital Trail.

**RECOMMENDATION:** City Administration recommends approval.

**BACKGROUND:** In partnership with CSX and the City, Capital Trees, and other civic and philanthropic organizations, have supported the development of the property as a linear green space attraction. Located within the area bounded by Dock Street to the north, Great Shiplock Park to the east, the Kanawha Canal to the south and 17th Street to the west Phase 1 of "the Low

Line" has completed the removal of invasive species, planting drifts of low-growing native grasses, perennials and ornamental plantings, improved lighting and tree canopy along the Virginia Capital Trail. Future phases include site furnishings, canal overlooks and boardwalk, gathering areas and a dynamic green space to be located under the I-95 overpass at the Virginia Capital Trail's western terminus. Educational signage and interpretive public art is to be displayed throughout the Low Line, detailing its significance in the slave trade, the industrial development of Richmond, area trade and transportation, as well as its environmental attributes and functionality.

In FY15 the City donated \$200,000 to Capital Trees to support Phase 1 plantings and other capital improvements. Improvements made by Capital Trees, accepted by the City are valued at approximately \$1,275,000. Earlier this year Governor McAuliffe named both the Low Line and Great Shiplock Park Virginia Treasures.
