THE CITY OF RICHMOND HEREBY ORDAINS:

- § 1. That the Chief Administrative Officer, for and on behalf of the City of Richmond, is authorized to accept funds in the amount of \$249,976.00 from the Virginia Department of Emergency Management for the purpose of purchasing a vehicle barrier system.
- § 2. That Article I, Section 2 of Ordinance No. 2023-071, adopted May 8, 2023, which adopted a Special Fund Budget for the fiscal year commencing July 1, 2023, and ending June 30, 2024, and made appropriations pursuant

thereto, be and is hereby amended by creating a new special fund for the Department of Emergency Communications,
Preparedness, and Response called the "FY24 Vehicle Barrier System Grant Special Fund" for the purpose of purchasing a vehicle barrier system.

- § 3. That the funds received from the Virginia Department of Emergency Management, are hereby appropriated to the Special Fund Budget for the fiscal year commencing July 1, 2023, and ending June 30, 2024, by increasing estimated revenues by \$249,976.00, increasing the amount appropriated for expenditures by \$249,976.00, and allotting to the Department of Emergency Communications, Preparedness, and Response's FY24 Vehicle Barrier System Grant Special Fund the sum of \$249,976.00, for the purpose of purchasing a vehicle barrier system.
 - § 4. This ordinance shall be in force and effect upon adoption.
