Call to Order

Council President Kristen Nye called the meeting to order at 6:13 p.m. and presided.

Chamber Security and Spanish Interpretation Announcements

Security policies and expected conduct for members of the public present in the Council Chamber were announced.

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. City Clerk Reid also stated that Spanish interpretation service was available virtually through Microsoft Teams.

Roxana Talavera-Denson, Language Access Coordinator, Office of Immigrant and Refugee Engagement, then provided Spanish interpretation of previously provided announcements.

Pastor Julius S. White of Community Christian Center, 2213 National Street, Richmond, Virginia, provided the invocation.

Members of Council and the audience recited the Pledge of Allegiance.

Public Comment

CD.2024.342 November 12, 2024 Public Comment Period Speakers List

Sereen Haddad addressed Council and requested that members adopt a proposed ceasefire resolution related to the conflict in Gaza. Ms. Haddad also addressed the conflict's impact on her family, and she further stated that Council could no longer remain silent about the conflict.

Nancy Rives addressed Council and requested that members adopt a proposed ceasefire resolution related to the conflict in Gaza. Ms. Rives also stated her concerns about the reaction to students and other members of the public that protested about the conflict.

Nakina Dunn, New Virginia Majority member, addressed Council and stated her concerns about her experience as a renter in the city. Ms. Dunn informed Council that she was assured safe code compliant housing from the property owner of her rental unit, but instead was provided a unit with bug infestations and other unsafe conditions. Ms. Dunn also addressed the legal proceedings associated with her trying to get the unsafe conditions addressed by the property owner.

Abraham Castillo, New Virginia Majority member, addressed Council and stated his concerns about housing issues experienced by the city's immigrant community. Mr. Castillo recommended that the city implement housing policies similar to Arlington County that would benefit Richmond's immigrant community.

Michaela Ross, Legal Aid Justice Center Senior Attorney, addressed Council and stated that she supported more rental assistance and services provided by the city for its residents. Ms. Ross also requested that the city take more action to enforce code requirements to ensure safe housing. Ms. Ross also stated the city should provide more rental relief assistance to city residents to prevent evictions.

Jana Hobbs, New Virginia Majority member, addressed Council and informed members about her concerns regarding stable housing in the city. Ms. Hobbs stated that many city residents will live in unsafe apartments because they fear losing access to their rental unit if the property is condemned. Ms. Hobbs requested that the city provide more funding to the Family Crisis Fund.

Bridgette Whitaker addressed Council and stated her concerns about affordable housing development in the city.

Rhonda Sneed, Blessing Warriors CEO, addressed Council and stated her concerns about access to emergency shelter in the city.

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to accept a donation of two road murals, one to be installed at the intersection of North 27th Street and Nine Mile Road and one to be installed at the intersection of North 28th Street and U Street, and maintenance services, all valued at approximately \$38,820.00 from Bon Secours - Richmond Community Hospital LLC for the purpose of supporting Bon Secours - Richmond Community Hospital LLC's Community Today, Community Tomorrow: Pathway to Wellness in the East End strategy.

16. <u>ORD.</u> 2024-278 To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to accept funds in the total amount of \$10,768,910.00 from the Federal Highway Administration and to amend Ord. No. 2024-100, adopted May 13, 2024, which accepted a program of proposed Capital Improvement Projects for Fiscal Year 2024-2025 and the four fiscal years thereafter, adopted a Capital Budget for Fiscal Year 2024-2025, and determined a means of financing the same, by (i) establishing a new project for the Department of Public Works in the

Transportation category called the "Safe Streets for All" project and (ii) increasing estimated revenues from the funds received from the Federal Highway Administration and the amount appropriated to the new Department of Public Works' Safe Streets for All project in the Transportation category by \$10,768,910.00, for the purpose of funding a Safe Streets and Roads for All program.

17. ORD. 2024-279

To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to accept funds in the total amount of \$18,400,000.00 from the United States Department of Transportation, to amend Ord. No. 2024-100, adopted May 13, 2024, which accepted a program of proposed Capital Improvement Projects for Fiscal Year 2024-2025 and the four fiscal years thereafter, adopted a Capital Budget for Fiscal Year 2024-2025, and determined a means of financing the same, to appropriate the increase to the Fiscal Year 2024-2025 Capital Budget by increasing estimated revenues and the amount appropriated to the Department of Public Works' Arthur Ashe Boulevard Bridge Replacement project in the Transportation - G.O. Bonds category by \$18,400,000.00, for the purpose of providing funding for the Arthur Ashe Boulevard Bridge Replacement project.

18. <u>ORD.</u> 2024-280 To authorize the special use of the property known as 3820 Hermitage Road for the purpose of a dwelling unit within an accessory building to a single-family detached dwelling, upon certain terms and conditions. (3rd District)

19. ORD. 2024-281

To authorize the special use of the property known as 7001 Jahnke Road for the purpose of motor fuels dispensing and a mixed-use building, upon certain terms and conditions. (9th District)

21. ORD. 2024-283

To establish the City-owned real estate known as 1305 North 5th Street as a cemetery in accordance with City Code § 7-21. (6th District)

Patrons: Mayor Stoney, Ms. Robertson, Vice President Lambert and Ms. Newbille

This ordinance was adopted.

It was the consensus of Council to permit speakers one minute and thirty seconds to provide comment during public hearings for the remainder of the meeting.

Public Hearing

Stephanie Starling spoke in opposition to ORD. 2024-281, and stated that the surrounding area would not support the proposed fuel station's increased traffic. Ms. Starling also stated that the fuel station would decrease public safety, and she noted her concerns about the amount of public noticing provided for the special use permit.

A copy of the material provided has been filed.

Joanne Myers spoke in opposition to ORD. 2024-281, and stated that the proposed mixed-use building was too ambitious for the size of the land parcel. Ms. Myers also stated her concerns about the lack of parking near the location.

Boralis Roland spoke in opposition to ORD. 2024-281, and stated that the proposed mixed-use building was subject to certain terms and conditions, and that he did not believe the development would adhere to the listed terms and conditions. Mr. Roland also stated that the project would negatively impact the community due to the increase of traffic.

Charles Samuels, attorney representing property owners and residents located at the 1200 block of West Cary Street, addressed concerns raised about ORD. 2024-198. Mr. Samuels stated that the development had no dedicated parking for residents, and that the overflow of new residents seeking parking and increased density would negatively impact the surrounding community.

Charles Myers spoke in opposition of ORD. 2024-281, and stated his concerns about city government's public outreach regarding the proposed development.

Marshall Haynes spoke in opposition to ORD. 2024-198, and he stated that he did not believe the proposed development was in compliance with city requirements.

Cindy Anderson spoke in support of ORD. 2024-264, and stated that the city's proposed purchase of the property would lead to more development in the 8th Voter District.

Christine Gibson spoke in support of ORD. 2024-264, and stated that 8th Voter District residents want more development to improve their quality of life.

Courtney Farrar, RVA Rapid Transit Ambassador, spoke in support of ORD. 2024-278, and stated that the Federal Highway Administration funding to be provided to the city would improve the safety of residents.

Emily Pinchbeck, 1321 Porter Street Property Manager, spoke in support of ORD. 2024-282, and stated that she followed the instructions of city staff regarding the special use permit and that she hoped Council would adopt the proposed ordinance.

Kevin Vonck, Department of Planning and Development Review Director, provided additional information regarding why the City Planning Commission continued ORD. 2024-282 to the December 3, 2024 City Planning Commission meeting.

Councilor Ellen Robertson addressed ORD. 2024-282, and she requested that members of the public be allowed to speak even though the ordinance was being continued.

Sophia spoke in support of ORD. 2024-282, and provided members with her experience as a former tenant of 1321 Porter Street. Sophia stated that she did not believe the city was correct in condemning the building.

Sue Mondeau spoke in support of ORD. 2024-282, and stated that she believed that the residents of 1321 Porter Street were unfairly impacted by city staff decisions.

Ross Butler spoke in support of ORD. 2024-282, and stated that he was a nearby neighbor.

Alyssa Regula, Chippenham Hospital employee, spoke in support of ORD. 2024-281, and stated that the proposed development would benefit hospital employees and nearby residents.

Jamie Dabney spoke in support of ORD. 2024-281, and stated the proposed development would benefit the surrounding neighborhood.

Indistinct name provided spoke in support of ORD. 2024-281, and stated that the proposed development would provide needed food options for nearby residents.

Will Gillette, Baker Development, representing the ORD. 2024-281 special use permit applicant, spoke in support and stated the special use permit would allow the renovation of an existing building that would provide more housing and food options, while also providing a fuel station.

Alessandro Ragazzi, Baker Development, representing the ORD. 2024-198 special use permit applicant, spoke in support and stated the development adheres to the Richmond 300 Master Plan and would provide much needed housing options in the city.

Mark Baker, Baker Development, representing the ORD. 2024-198 special use permit applicant, spoke in support and provided Council with a legislative history of the special use permit request and community outreach by the applicant.

Lenora McQueen spoke in support of ORD. 2024-283, and stated that the Shockoe Hill Burial Ground was a historically significant cemetery that should be protected.

Councilor Nicole Jones stated that two town hall meetings took place within the 9th Voter District regarding the proposed development referenced in ORD. 2024-281. Councilor Jones also stated that residents and local businesses informed her of their support for the proposed development. Councilor Jones informed members that she also supported the development.

Councilor Stephanie Lynch asked for more details about the concerns raised by residents regarding ORD. 2024-198.

Charles Samuels, attorney representing property owners and residents located at the 1200 block of West Cary Street, stated that ORD. 2024-198 contained inaccurate maps depicting both a large amount of residences and designated parking spots. Mr. Samuels informed Council that he did not believe the ordinance should be adopted with such discrepancies.

Mark Baker, Baker Development, representing the ORD. 2024-198 special use permit applicant, stated that one map depicted the current condition of the parcel with the parking lot, and that the second map containing the large residential development, depicted the proposed changes.

Councilor Reva Trammell stated appreciation for individuals that spoke in support of ORD. 2024-264. Councilor Trammell also stated the opportunity for the city to purchase such a large amount of land for potential development was rare, and that the city should initiate the purchase. Councilor Trammell further stated the property could be used to offer city resources to residents located in the city's Southside.

Councilor Ellen Robertson requested to be added as a co-patron of ORD. 2024-270, ORD. 2024-278, and ORD. 2024-282. Councilor Robertson stated she was concerned that city administration had not presented any proposed development plans for the proposed land purchase referenced in ORD. 2024-264. Councilor Robertson requested that city administration provide more information to Council regarding potential development plans.

Chief Administrative Officer (CAO) Lincoln Saunders provided information about potential uses of the land, and he noted the desire to have fifty acres remain as greenspace, create facilities to provide city services, and increase traffic connectivity for Southside residents. CAO Saunders stated the city is open to different scenarios, but that it must first purchase the land.

Sharon Ebert, Deputy Chief Administrative Officer (DCAO) for Planning and Economic Development, provided additional information regarding the proposed purchase and stated it was a great opportunity for the city.

Vice President Ann-Frances Lambert and Councilor Cynthia Newbille requested to be added as co-patrons of ORD. 2024-283.

President Kristen Nye stated her support for the development project referenced in ORD. 2024-281.

There were no further comments or discussions and the Consent Agenda was adopted: Ayes 8, Jordan, Jones, Robertson, Lynch, Trammell, Newbille, Lambert, Nye. Noes None. Addison was excused.

The Regular Agenda

The following ordinances were considered:

24. ORD. 2024-222

To amend and reordain City Code § 26-355, concerning the levy of tax on real estate, to establish a tax rate of \$1.16 for the tax year beginning Jan. 1, 2025, pursuant to Va. Code § 58.1-3321(b), and increasing such rate from the Rolled Back Tax Rate of \$1.136 as computed in accordance with Va. Code § 58.1-3321(a).

Patrons: Ms. Trammell, Ms. Robertson and Vice President Lambert

This ordinance was rejected.

25. ORD. 2024-223

To amend and reordain City Code § 26-355, concerning the levy of tax on real estate, to establish a tax rate of \$1.20 for the tax year beginning Jan. 1, 2025, pursuant to Va. Code § 58.1-3321(b), and increasing such rate from the Rolled Back Tax Rate of \$1.136 as computed in accordance with Va. Code § 58.1-3321(a).

Patrons: President Nye

Councilor Reva Trammell provided an introduction and additional background information regarding ORD. 2024-222 and the proposed \$1.16 real estate tax rate.

President Kristen Nye provided an introduction and additional background information regarding ORD. 2024-223 and the proposed \$1.20 real estate tax rate.

Public Hearing

Cindy Anderson spoke in support of ORD. 2024-222 and the proposed \$1.16 real estate tax rate. Ms. Anderson stated the real estate tax rate impacts rental rates in the city and that the city should lower the rate to help renters remain in their current residences.

Bonnie Atwood spoke in support of ORD. 2024-222 and the proposed \$1.16 real estate tax rate. Ms. Atwood stated rising assessments made it difficult for long-term residents to remain in the city, and she requested that the rate be reduced.

William Earl Andrews, city employee retiree, spoke in support of ORD. 2024-222 and the proposed \$1.16 real estate tax rate. Mr. Andrews stated the lack of cost-of-living adjustments for city retirees made it difficult to remain in the city as real estate assessments continue to increase. Mr. Andrews also stated that proposed tax relief programs would not help all the residents in need of tax relief.

Councilor Ellen Robertson stated that city revenue has increased due to the rise in city real estate assessments. Councilor Robertson also stated that the city was becoming unaffordable for some, and she requested that city administration provide details on city revenue increases due to rising assessments. Councilor Robertson informed members that she supported lowering the city real estate tax rate to \$1.16.

Chief Administrative Officer (CAO) Lincoln Saunders addressed Councilor Robertson's questions and provided more details about city revenue, city expenditures, and tax relief programs. CAO Saunders also stated cutting the city budget and lowering taxes should occur during the budget review process.

Councilor Katherine Jordan informed members that she supported ORD. 2024-223 and the real estate tax rate of \$1.20, because of the tax relief programs the higher rate would provide certain city residents. Councilor Jordan also stated that future federal funding was uncertain due to the recent United States presidential election. Councilor Jordan further stated her concerns that lowering the real estate tax rate could hurt the city's ability to borrow money.

Councilor Nicole Jones stated she was concerned that the city was not ready to adjust the budget if the real estate tax rate was lowered. Councilor Jones also stated that city administration needed to better assist city residents with applying to available tax relief programs.

Councilor Cynthia Newbille stated financial uncertainties prevented the city from lowering the real estate tax rate, such as completing collective bargaining agreements with city employees. Councilor Newbille also stated her support for the tax relief programs that would be funded by maintaining a \$1.20 real estate tax rate. Councilor Newbille further stated that the city could look at lowering the real estate tax rate in the future.

Vice President Ann-Frances Lambert stated that residents are experiencing housing affordability issues. Vice President Lambert also stated that more affordable housing developments are needed, and she informed members that she supported lowering the real estate tax rate to \$1.16.

There were no further comments or discussions and ORD. 2024-222 was rejected: Ayes 4, Robertson, Lynch, Trammell, Lambert. Noes 5, Addison, Jordan, Jones, Newbille, Nye.

There were no additional comments or discussions and ORD. 2024-223 was unanimously adopted.

The following ordinances were considered:

29. ORD. 2024-272

CAO Saunders stated he was uncertain, but that he believed it depended on the recipient's financial situation.

Public Hearing

Gustavo Espinosa, Legal Aid Justice Center Tenant Organizer, spoke in support of ORD. 2024-272, and stated that the gap grant program for income-based housing grants would help city residents in need of tax relief.

Warren Campbell, New Virginia Majority Community Organizer, spoke in support of ORD. 2024-272, and stated that he appreciated the pilot program but requested that more funding be allocated to assist housing instability. Mr. Campbell also requested that any work force development requirement from recipients actively working be removed.

Michaela Ross, Legal Aid Justice Center Senior Attorney, spoke in support of ORD. 2024-272, and stated that more rental assistance was necessary for city residents.

Jana Hobbs, New Virginia Majority member, stated that renters need assistance to remain housed.

Councilor Stephanie Lynch stated her support for the targeted tax relief provided by the proposed ordinances.

Councilor Cynthia Newbille requested to be added as a co-patron of ORD. 2024-272, ORD. 2024-273, and ORD. 2024-277.

Councilor Nicole Jones requested that city administration provide Council with more details regarding the tax relief programs, and she also noted her prior request that the workforce training requirement not be applicable to recipients that are employed.

Councilor Ellen Robertson inquired if a future appropriation ordinance would be necessary to ensure funding for the proposed rent relief programs.

CAO Saunders stated he did not believe a subsequent appropriation ordinance would be necessary.

Vice President Ann-Frances Lambert stated she appreciated the proposed tax relief programs, but she requested that City Council continue to look at reducing the city real estate tax rate in the future.

President Kristen Nye stated she agreed with Councilor Jones, and she requested that city administration ensure sufficient outreach is made to residents about the tax relief programs.

Katherine Joelle spoke in support of the ordinances and stated RACC assists residents from all backgrounds.

Mary Baltimore, RACC Foundation President, spoke in support of the ordinances and stated that the RACC Foundation Board supported the purchase of the new facility.

Dr. Charlene Noll, Woodside Equine Clinic Veterinarian, spoke in support of the proposed ordinances and stated that the new facility would help increase the positive impact animals have on residents.

Brittany McBean spoke in support of the proposed ordinances and stated that neighborhoods with higher animal populations have fewer crime incidents. Ms. McBean also stated the new shelter would help increase animal adoption rates in the city.

Todd Woodson, Richmond Animal Advocacy Alliance President, Humane Society of the United States Policy Advisor, spoke in support of the proposed ordinances and stated that the new facility would benefit the city.

Betty Miyako spoke in support of the ordinances and stated the new facility would help RACC increase potential adoptions.

Dr. Ella Rak, Virginia Veterinary Centers Veterinarian, spoke in support of the ordinances and stated that RACC is an organization that provides much needed services to residents and animals in need.

Jon Bridges, Richmond Police Department (RPD) Sergeant, RACC volunteer, RPD Liaison to RACC, spoke in support of the ordinances and stated he had confidence that RACC would effectively use the new facility.

Dr. Patrick Bales, UrgentVet Carytown Veterinary Clinic Veterinarian, spoke in support of the ordinances and stated RACC needs the new facility to expand and continue the services it provides residents.

Dr. Joseline Torrence, UrgentVet Carytown Veterinary Clinic Veterinarian, spoke in support of the ordinances and stated RACC helps residents in crisis situations. Dr. Torrence also stated the new facility would help RACC expand the services it provides residents.

Kensey Jones, RACC volunteer, spoke in support of the ordinances and stated that she deeply believed in the mission of RACC.

Lauren Wade spoke in support of the ordinances and stated the new facility would provide more space for the emergency sheltering of animals in crisis. Erin Bailey, RACC volunteer, spoke in support of the ordinances and stated the new facility would provide a more inviting environment for potential animal adopters.

Heather Euler, RACC volunteer, spoke in support of the ordinances and stated the facility would provide a better environment for stressed animals recovering from a crisis.

Phyllis Klaust, RACC volunteer, spoke in support of the ordinances and stated she believed in RACC's core values.

Melanie, RACC volunteer, spoke in support of the ordinances and requested that Council be aware of the positive impact of RACC.

Barbra Elledge, RACC volunteer, RACC Foundation Board member, spoke in support of the ordinances and stated that the new facility would help stressed animals decompress in a calm environment.

Jessica Holt, RACC volunteer, spoke in support of the ordinances and stated the new facility would help stressed animals recovering from a crisis be adopted.

Jennifer Racusso spoke in support of the ordinances and stated adopted animals provide a positive impact on their adopter. Ms. Racusso also stated the new facility would benefit city residents and not just animals.

Pam Wright, Richmond Public Schools (RPS) teacher, spoke in support of the ordinances and stated that the new facility had great potential.

Ashley Calkins, RACC volunteer, spoke in support of the ordinances and stated that RACC needed the support of the new facility.

David Calkins spoke in support of the ordinances and stated that RACC has had a large impact on the city. Mr. Calkins also stated the new facility was a strong investment for the city.

Mellissa Grotman spoke in support of the ordinances and requested that the new facility provide the same care and attention to cats that dogs receive.

Dr. Laura Turner, Virginia Veterinary Centers Veterinarian, spoke in support of the ordinances and the work of RACC.

Sarah-Ann Diamond spoke in support of the ordinances and stated that the facility would help residents in need of pet supervision when undergoing necessary medical treatments.

Susan Coombes, RACC volunteer, spoke in support of the ordinances and stated the new facility would benefit RACC staff.

Vice President Ann-Frances Lambert asked for the operating costs if the city had two functioning animal shelters.

Christie Peters, RACC Director, stated the new facility would require \$26,000 a year for operating costs.

Councilor Katherine Jordan inquired if the new facility was big enough and if the city had looked at other facility options.

Director Peters stated the proposed facility met RACC's needs, such as location, size and costs.

Councilor Nicole Jones asked if the new facility location would prevent RACC from providing services to city residents throughout the city, and she inquired if the new location was accessible by public transit.

Director Peters stated the new location was located on a bus line, and she added that the current RACC facility on Chamberlayne Avenue would still provide the same services to city residents.

Councilor Ellen Robertson asked about the animal population planned for both RACC facilities, and she inquired if different services would be provided at each facility.

Director Peters stated that the same care would be provided at each location, but that the new location on Cary Street would be the primary adoption site.

Councilor Reva Trammell stated her appreciation for Director Peters and noted her support for the requested RACC expansion.

Councilor Ann-Frances Lambert requested more information on RACC's operational timeline for the new facility.

Director Peters stated RACC planned to have the site operational in six to twelve months.

Councilor Cynthia Newbille suggested that RACC continue to utilize the current Chamberlayne Avenue facility to provide assistance to the city's unhoused population.

Councilor Stephanie Lynch stated her concerns that unhoused individuals in the city were not being prioritized over the housing of animals. Councilor Lynch also stated that she believed the city's most vulnerable residents were being ignored as a funding priority.

Councilor Ellen Robertson stated she agreed with Councilor Lynch's concerns and that the city was not prioritizing unhoused residents. Councilor Robertson also stated her concerns that the city was not addressing infrastructure improvements needed to increase resident safety.
