Adopting the Wastewater Utility Budget for the fiscal year commencing July 1, 1986, and ending June 30, 1987, and appropriating the estimated receipts of the Wastewater Utility for said fiscal year.

1. THE CITY OF RICHMOND HEREBY ORDAINS:
2. § 1. That the budget designated the Wastewater
3. Utility Budget for the fiscal year commencing July 1, 1986,
4. and ending June 30, 1987, bound with the draft of the
5. general fund budget, a copy of which is attached to the
6. draft of the general fund budget ordinance, is hereby
7. adopted and made a part of this ordinance.
8. § 2. That the sum of \$15,214,800 be and is hereby
9. appropriated from the estimated receipts of the wastewater
10. utility for the fiscal year 1986-1987 for salaries, wages
11. and other expenses, including acquisition of equipment
12. necessary for collection of wastewater through Intercepting
13. Lines, Power and Pumping, Treatment and Testing, Customers'
14. Accounting and Collecting and Administration of the Waste-
15. water Utility as set forth in the Wastewater Utility Budget.

1. § 3. That the payment and settlement of claims of
2. any kind heretofore or hereafter asserted against the City
3. growing out of the operation of the wastewater utility and
4. final judgments heretofore or hereafter asserted against the
5. City on account thereof, together with all costs, interest,
6. fees for legal services and all other fees and expenses
7. incident thereto, and all fees, costs and other expenses
8. incurred in providing legal and other services authorized by
9. Section 2-37.10 of the Code of the City of Richmond, 1985,
10. shall be paid upon the approval and order of the City
11. Attorney from the funds herein appropriated for defraying
12. the expense of operating the wastewater utility; except that
13. in the case of judgments against the City, payment thereof
14. shall be limited to the extent of funds available in the
15. appropriation for the purpose.

16. § 4. This ordinance shall be in force and effect at
17. the first moment of the first day of July 1986, and shall
18. constitute the wastewater utility appropriation ordinance
19. for the fiscal year commencing on that date.
