Members appointed to the commission shall either reside or have a principal place of employment in the city of Richmond.

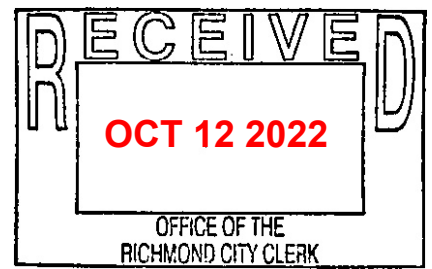
