Accessing the Meeting:

- 2. Access the meeting by phone**

All written comments received via email prior to **10:00 a.m. of the date of the meeting referenced above** will be provided to all members of the Planning Commission prior to the beginning of the meeting and will be included in the record of the meeting.*

When submitting your comments by email, be sure to include in your email (i) your full legal name, (ii) any organizations you represent, and (iii) any economic or professional relationships that would be affected by the adoption of the legislation on which you are commenting.

- 2. Provide public comment regarding items on the agenda during to the meeting**
