



Cedar Street Memorial Baptist Church of God

The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to officially recognize, honor and celebrate Cedar Street Memorial Baptist Church of God in Richmond, Virginia on the occasion of its historic 150-year anniversary sesquicentennial.

Founded in Richmond, Virginia in 1867, Cedar Street Memorial Baptist Church of God is presently located at 2301 Cedar Street in the Richmond East End 7th Voter District (at the intersection of Cedar and 24th Streets) and serves as an iconic and stalwart landmark in the Historic Union Hill Neighborhood of our beautiful capital city.

In 1918, the church moved from Cedar Street to 1001 Mosby Street, where it remained for several years. During that time, due to the small size of its congregation, the church could only afford to build a concrete basement on the site, with plans to eventually erect a sanctuary above when funds allowed.

In December 1951, Union Station Methodist Church vacated its edifice at the intersection of N and 24th Streets. In February 1952, Cedar Street Baptist Church purchased the building and relocated to this larger sanctuary. In the years following, the congregation voted to change the name of the church to Cedar Street Memorial Baptist Church of God.

Cedar Street Memorial Baptist Church of God built a new sanctuary in October 1980 with a seating capacity of 1,488, which is still in use to this day. The church also began a television ministry in 1989, broadcasting on Sunday mornings on WRLH Fox channel 35.

In February 1993, the City of Richmond adopted an ordinance to rename portions of N Street, Pleasants Street, and 19th Street to Cedar Street. Because of this, nearly 75 years after its initial move, Cedar Street Memorial Baptist Church of God was once again located on a Cedar Street.

Cedar Street Memorial Baptist Church of God has grown over time and its dedicated members have continued to provide and expand programs and services on behalf of its congregation. Such programs have included providing cold weather shelter for the homeless, hosting onsite Alcoholics Anonymous meetings, serving Thanksgiving Day meals to the needy, and hosting annual National Night Out block parties. The church's current pastor, Dr. Anthony Michael Chandler, Sr., also serves as a member of the Richmond Police Department Faith Leaders Partnership.

Now, Therefore, The Honorable Members of Richmond City Council do hereby officially recognize, honor and celebrate Cedar Street Memorial Baptist Church of God, in Richmond, Virginia, on the occasion of its 150th anniversary; and, bring this to the attention of all Richmond residents.

In Witness Whereof, we have hereunto given under our hands for presentation on the fifth day of November, two thousand seventeen, of the Common Era, in the two hundred eightieth year of the foundation of Richmond in 1737, in the two hundred forty-first year of the Commonwealth of Virginia and United States of America.
