As discussed during our phone conversation on 30 Nov 22, I am writing you this narrative regarding an awful exchange with Mr. Tavares Floyd, Esq. on the 29 Nov 22.

On the 29 Nov 2022, my wife and I were returning to our apartment building (1611 4th Ave) after running errands we observed a black Mercedes Benz occupying several spaces in the designated parking area of this complex; parked in a manner that obstructed any other vehicles from having access to a park on either side of his automobile. The vehicle was angled parked which would prevent two other residents from having a space to park next to his automobile.

After dropping off the items that my wife and I had purchased in our apartment, I had to make another trip to the store. Once in the parking area, I observed the above mentioned automobile in the same location. While out on this errand, my wife phoned to inform me of a meeting with Mrs. White (Resident Manager) and that I should stop in her office upon my return. I did meet with Mrs. White but did not mention the car issue to her as there were others present. I chose not to change the subject. The automobile was still in its' same location. The meeting with Mrs. White and others lasted a spell. Upon returning to my apartment at about four-ish (4:00 PM), my wife phoned Mrs. White regarding the automobile. She stated that she would investigate the issue. Whether she did or did not, neither my wife nor I can say. Mrs. White left the premises. We don't know if she made contact with the automobile owner or not. However, the automobile remained in the same location after Mrs. White had departed. At about 4:20 PM, I had cause to go back out. As I existed the elevator on the 1st floor, Mrs. Watts (a resident) and a bloke were standing at the elevators' exit doors as they opened waiting to board it. As I was existing the elevator I inquired of the bloke, casually, if he were the driver of the automobile. His response was an outburst of rage including expletives laced with "Mother Fu_ers". He stated that he could park where he wanted to and I didn't know who he was. I said to him, "I didn't curse you". He dropped another "F" bomb toward me. As I was turning to exit the building (an attempt to de-escalate) I mentioned that I intended to take pictures of the automobile. His retort was another "F you", etc. "boasting", I didn't know who he was and he could park where he wanted to. It shows his presence of mine when he parked his vehicle. He thinks more of his property then the tenants residing In this complex. He has illustrated that there may be other issues happening in his life. His response, attest to my perception of his character. I took the pictures of the car in question and they are enclosed with this letter.

My wife related to me his identity after the encounter. It was astounding to learn that he is an attorney and also your liaison. My question, is this outrageous behavior indicative of the persons representing the voters in this district, your office or the capital city of Virginia? Is this an acceptable behavior for anyone; most especially disturbing, is Mr. Floyd's position as a representative of an office of a city council member in the Commonwealth of Virginia. I am a voter, and voted here, in Richmond. I am seventy-seven years of age and have been voting since becoming eligible to do so. He (Mr. Floyd) is an "officer of the court". He has offered commentary regarding police reform. His behavior was opprobrious. There is a lot of reforming necessary to humanize us all, Mr. Floyd included. As well as displaying a recalcitrant attitude toward law and order; hence, his abusive language and disregard for any tenant's privilege and right to park at this complex warrants serious consideration about his ability to control his impulses: to wit, mindfulness of his surroundings and communications with others.

I deserve a personal apology from him, not your office, and hope that this issue serves as a learning experience for us all going forward.

I thank you for your attention regarding this horrible incident. The pictures are enclosed. As is said, "A picture" is worth a thousand words. I wish you continuing success as a council member of our district.
