

**BACKGROUND**

This O&R is requesting appointment of Kennon C. Wright as Council Liaison with the Richmond City Council Office.

This request is in accordance with Richmond City Code §2-29. which states, "The City Council may provide for the appointment of a Council Liaison for each member of the Council to assist the members with administrative support and responding to constituent concerns. The Council Liaison shall be appointed by the City Council for an indefinite term and shall be a member of the unclassified service".

Mr. Wright's start date of employment is March 13, 2023, therefore the effective date for Council appointment is March 13, 2023. The O&R requested date of introduction is March 13, 2023.
