
THE CITY OF RICHMOND HEREBY ORDAINS:

ORDINANCE/RESOLUTION SUMMARY

The patron request is to amend Ord. 2021-40, adopted May 24, 2021, which adopted the Fiscal Year 2021-2022 General Fund Budget to change the uses and allocation of the Council District Funds for the Fifth District and amends the 5th District FY23 Anticipated Council District Expense List.

BACKGROUND

The purpose of this amendment is to comply with requirements of VA Code Section 15.2-2503, which requires that a locality's budget stipulate how local governing body discretionary funds will be used. This Section allows individual members of the governing body to propose amendments during the fiscal year to change the uses and allocation of those discretionary funds.
