**1. Access the meeting by phone:**

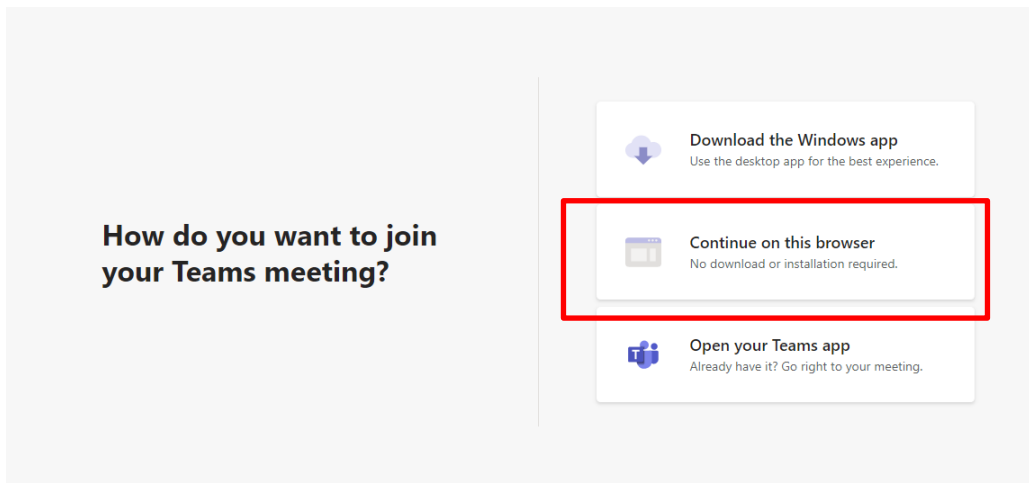
You may listen to the meeting audio only from your phone by dialing \*67-804-316-9457 and when prompted, enter conference ID 167 282 020#
