Established by the adoption of Ord. No. 2021-347 (as amended) on March 14, 2022, the purpose of the Commission is to conduct a comprehensive review of the Charter of the City of Richmond (2020), as amended, with the objective of making recommendations for appropriate revisions to such charter. The Commission shall consist of **nine (9)** members that are persons appointed by the City Council, who meet one or more of the following qualifications:

- (1) A person with substantial experience in local government, based on either practical experience or academic research; or
- (2) A person who is a citizen-at-large of the city

Members appointed to the commission shall either reside or have a principal place of employment in the city of Richmond.

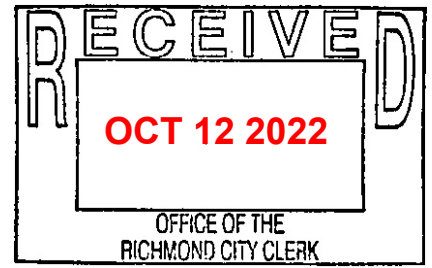

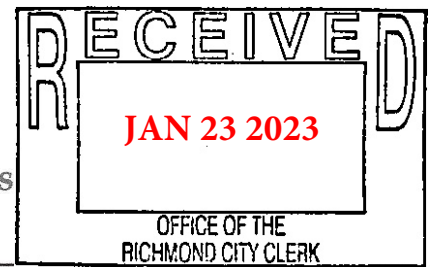
