### **Call to Order**

Chief Administrative Officer Lincoln Saunders provided an introduction and answered questions regarding Ord. 2022-169.

Megan Fields, Office of the Chief Administrative Officer senior policy analyst, was available to answer additional questions regarding proposed Ord. 2022-169 and provided background information pertaining to the foundation tasked with administering the voluntary gun buyback program.

Vice President Ellen Robertson requested information concerning the memorandum of understanding associated with the proposed program and additional foreseen city initiatives to reduce the current uptick in gun violence.

Councilor Ann-Frances Lambert expressed her support for Ord. 2022-169.

Councilor Michael Jones acknowledged the proposed adoption of Ord. 2022-169 will not deter gun violence in the city.

Councilwoman Reva Trammell requested a clarification of the monetary incentive of the proposed gun buyback program.

Vice President Robertson also requested a method to evaluate the impact of Ord. 2022-169, if adopted, and encouraged the revisiting of community policing as an effective method to combat the recent rise in crime.

Councilwoman Trammell mentioned the lack of morale in the police department and the need to increase staffing levels.

Given the recent introduction of state budget amendments barring the city from holding a second referendum for a casino and possibly the granting of a casino license, Chief Administrative Officer Lincoln Saunders explained that city administration is awaiting the final adoption of the state budget to determine the city's legal recourse regarding the referendum.

Interim City Attorney Haskell Brown informed Council that the city registrar, on behalf of the city, is still obligated to follow a court order to provide for a second referendum on the 2022 November ballot regarding the approval or disapproval of a casino in the city.
