As a Richmond resident who is very active and involved in the Richmond queer community and scene as well as an employee of Papi's, it deeply saddens me that Papi's was shut down and is still not being allowed to be reopened by the city. Papi's was greatly loved by so so many in the city. It's been nearly 10 months since we were shut down and I am still approached by strangers out in public every single week asking me if and when Papi's will reopen. They tell me that they loved the space and miss it dearly. They tell me that it was the one establishment in Richmond that made them feel fully welcomed, safe, appreciated, and able to authentically be themselves. Papi's impact on queer (and also straight) people was so vast that it extended past Richmond's bounds. I was even approached at a queer bar in Roanoke, VA, which is 200 miles away, just this past Saturday night (October 4th) by an individual whom I had never met. Hi there,

I am writing because I am aware that there is a campaign underway by the Shockoe Partnership to misinform your body about the nature of Papi's and its surrounding environment.

I learned yesterday that the Shockoe Partnership has submitted a document describing the Shockoe Slip area where Papi's is located as "predominantly residential" for which "late night activity is incompatible and at odds with healthy growth for the district." That document also asserts that the existence of Papi's--that is, its ability to simply operate as a business--creates an "atmosphere [that] is unwelcoming to visitors who may be patronizing other businesses." I find both of these points to be, at best, deeply disingenuous, and at worst, maliciously self-interested.

I was, I will say, quite surprised to see Shockoe Slip defined as "predominantly residential". Having worked in the neighborhood since 2013, I would have described it as "predominantly commercial". In fact, since my first visit to Richmond in 2010, Shockoe Slip has been not only home to, but defined by the string of restaurants along Cary St. that double as raucous nightclubs. The fundamental identity of the neighborhood and its economy is the very "late night activity" that the Shockoe Partnership claims is antithetical to the district's growth.

I was also deeply concerned by the subtext of the language being used to describe the atmosphere created by Papi's. Papi's is one of only four bars dedicated to Richmond's LGBTQ+ community, and the only such venue in the downtown/Shockoe area. It is inherently an inclusive space, and as such it attracts a diverse and queer clientele. As it is a popular venue, it is inherently loud. I am not aware that the Shockoe Partnership has intervened to try to interrupt the operation of the myriad other businesses in the district (for instance, Southern Railway Taphouse, Sine, etc.) which attract crowds that are larger, more disruptive, equally as dense, and less accepting of queer people. In light of these circumstances, it is very difficult to perceive the arguments that the Shockoe Partnership is advancing as anything other than an attempt to co-opt the mechanisms of local government in a discriminatory way.

I will say also--Papi's is not my favorite bar, and I did not frequently patronize it. If it is allowed to reopen, I probably will not spend much time there. But I could not stand by idly and watch it be so transparently mischaracterized by a group with such obvious ulterior motives. I hope you will flatly reject the request by the Shockoe Partnership, and do what is within your power to help Papi's re-open.

I am writing as a former resident of Richmond to express my strong support for the reopening of Papi Nightclub.

Papi was more than just a nightclub — it was a gathering place where young college students, professionals, and adults came together to enjoy music, laughter, and a true sense of community. It welcomed everyone, regardless of their background or identity, and created a *free*, *safe space* where people could celebrate Richmond's diversity.

There has been much discussion about the reasons for its closure. I strongly believe that its open support of the LGBTQ+ community played a role, whether directly or indirectly. If that is the case, it is deeply concerning. Countless other nightlife venues — such as Taphouse, Bellos, Sine, Stadium, and La Margaritas — remain open without similar issues. Singling out Papi feels unfair and discriminatory.

During my many visits, I never witnessed violence or unsafe behavior inside the establishment. I am not a member of the LGBTQ+ community myself, but I am a strong ally. Watching friends who *are* part of that community feel free, loved, and accepted in that space was indescribable. I often brought friends from out of town to Papi, and they consistently said it was the one Richmond nightclub where they had the best time of their lives.

Closing Papi under the belief that it would reduce crime is extremely misguided. Violence in the city will NOT disappear because one inclusive venue is shut down; it simply shifts elsewhere. Targeting Papi — a space that brought joy, unity, and acceptance — sends the message that enforcement is not being applied equally, and possibly in a discriminatory way.

Its closure also made me realize how much I took that atmosphere for granted. My friends and I have been hoping and praying for Papi to reopen, because it was one of the few places where minorities felt welcomed, safe, and free to enjoy themselves. Other nightlife spots, like Taphouse, tend to cater primarily to the white community. Papi was different — it was rare and valuable because it created belonging for *everyone*.

If you look on TikTok and other social media platforms, you will see thousands of people expressing how much they miss Papi, how unfair its closure feels, and how Richmond's nightlife has not been the same since. The outpouring of voices online shows just how deeply the community values this space and wants it back.

I also think of the workers who built a family there, both with each other and with the patrons they saw every weekend. That bond has been broken, leaving many people without the community they cherished. Richmond's nightlife has lost a unique heartbeat, and people no longer feel the same excitement to go out because that vibrant, inclusive space is gone.

I respectfully urge the City of Richmond to reconsider this closure and allow Papi Nightclub to reopen. Doing so would restore not only a beloved nightlife option but also demonstrate that Richmond stands for fairness, inclusivity, and a thriving, diverse community.

## Kevin:

I am writing to confirm The Shockoe Partnership's opposition to the conditional use permit CU-166261-2025 for the establishment of a 'Nightclub' use at 1407 East Cary Street. The reasons for our opposition are:

- There was no attempt to get community input for this conditional use prior to Planning staff deciding to recommend approval. A modest effort to gather information about the predominant uses in this Shockoe district, we believe, would have led to a different outcome. The applicant did not contact The Shockoe Partnership until after your decision was made.
- The approval was given without adequate due diligence to verify basic elements of the petition for approval, as well as the operational history of the applicant in this location. For example, misleading and inaccurate statements were made by the applicant suggesting an existing ABC license for the space. In fact, the license to operate had lapsed and then been revoked by the ABC Board after their review of a long list of violations and illegal activity. And, the Papi's history of recent operations show numerous and negative interactions with RPD, the Richmond Fire Department, and sanctions brought about by inspectors from the Planning office in January of this year. Each of these should be disqualifying events for any applicant.

• The mixed-use entertainment district is meant to support vibrant and varied use groups. It is well documented that the nightclub use is creating an environment that makes it very difficult for other designated uses to thrive safely. This atmosphere is unwelcoming to visitors who may be patronizing other businesses and harmful to residents in the vicinity of these clubs. The area around this proposed use is predominantly residential, for which this late night activity is incompatible and at odds with healthy growth for the district. The safety and well-being of the 1,500 residents has to be the primary consideration in your decision making.

Our meeting last month provided an opportunity for The Shockoe Partnership to share our concerns about this proposed change. We are opposed to this establishment being granted a a CUP for nightclub use and request that you rescind the staff approval for this application.
