Kayla Marshall addressed Council and stated that her neighborhood was experiencing a difficult trash issue. Ms. Marshall informed Council that a large amount of trash collects on her street due to certain neighbors not removing trash receptacles from the street. Ms. Marshall further stated that the trash pile continuously attracts rodents and makes it difficult to safely walk on the block. Ms. Marshall also informed Council that when the city does remove the trash build up, it quickly returns. Ms. Marshall requested that the city enforce its trash ordinances, and she provided Council with images of the trash build up.

Public Hearing

Martin Wegbreit, Affordable Housing Trust Fund Supervisory Board Member, legal aid housing attorney, and Richmonders Involved with Strengthening our Community (RISC) Member, stated that the city needed to dedicate more of the city's budget to the Affordable Housing Trust Fund and that the city needed to establish a dedicated revenue stream for the Affordable Housing Trust Fund. Mr. Wegbreit also stated that the city should not rely on stimulus funding to address the needs of affordable housing.

Brandon Graves, VA Leading Men Fellowship Program Manager at The Literacy Lab, provided Council with additional information regarding the work of the VA Leading Men Fellowship Literacy Lab Program, and its efforts to provide opportunities for young men to mentor youth. Mr. Graves requested that Council adopt ORD. 2022-054 and allocate \$96,250.00 in funding to The Literacy Lab.

There were no further comments or discussions and the Budget Related Ordinances were unanimously adopted.

Councilor Ann-Frances Lambert stated her appreciation for the collaborative efforts between Council and city administration regarding the review and adoption of the FY23 budget.

Vice President Ellen Robertson stated her appreciation of Council and Council staff for the work conducted throughout the FY23 budget process.

Councilor Andreas Addison stated his appreciation for the work that contributed to the adoption of the FY23 budget.

Councilor Katherine Jordan stated her appreciation for residents that provided feedback throughout the FY23 budget process and also stated she was proud of the work accomplished during the FY23 budget process.
