Call to Order

Chairwoman Reva Trammell called the meeting to order at 12:02 p.m., and presided.

Electronic Meeting Announcement

Assistant City Clerk Jamie Isley, in accordance with Ordinance No. 2020-093, adopted April 9, 2020, as amended by Ordinance No. 2020-183, adopted August 20, 2020, announced the meeting would be held through electronic communication means. Approval of Minutes

There were no amendments or corrections to the meeting minutes of Tuesday, September 29, 2020, and the committee approved the minutes as presented.

Board Vacancies

Assistant City Clerk Pamela Nichols reviewed board applications for consideration by the committee.

Vice Chair Kim Gray informed the committee of the Richmond Ambulance Authority's (RAA) request to continue consideration of RAA board vacancies until after the November RAA board meeting.

Member Chris Hilbert moved to continue consideration of the following appointment applications for the Richmond Ambulance Authority to the November 24, 2020, Public Safety Standing Committee meeting, which was seconded.

Assistant City Clerk Pamela Nichols advised the committee that it would be prudent to continue consideration of the applications for the Richmond Ambulance Authority to the next quarterly review cycle of pending board vacancies in January 2021.

Assistant City Clerk Pamela Nichols reviewed the applicants and criteria for appointment to the Task Force on the Establishment of a Civilian Review Board. She also reviewed a letter received from the Richmond Transparency and Accountability Project (RTAP) with applicant recommendations.

A copy of the material provided has been filed.

Vice Chair Kim Gray suggested John I. Dixon, III who is a former police chief for the city of Petersburg, John Gerner who was vice president of the Navy Hill Development Advisory Commission, and Dr. Eli Coston, who is a member of RTAP and has worked with the Council previously, be recommended for appointment to the Task Force on the Establishment of a Civilian Review Board.

Councilor Michael Jones suggested Angela Fontaine, who has a sociology and criminal justice background, be recommended for appointment to the Task Force on the Establishment of a Civilian Review Board.

Vice Chair Gray advised against accepting all of the recommendations made by RTAP to avoid too much influence by any certain organization.

Chairwoman Reva Trammell suggested Charlene Hinton be recommended for appointment to the Task Force on the Establishment of a Civilian Review Board.

Assistant City Clerk Pamela Nichols informed the committee that Keith Anthony Turner applied for the person with a disability vacancy and was also recommended for appointment by RTAP.

It was the consensus of the committee to recommend the approval of Keith Anthony Turner's application for the person with a disability vacancy on the Task Force on the Establishment of a Civilian Review Board.

Vice Chair Gray suggested Edward Miller be recommended for appointment to the Task Force on the Establishment of a Civilian Review Board.

Councilor Jones recommended Jewel Gatling be recommended for appointment to the Task Force on the Establishment of a Civilian Review Board, and agreed with Vice Chair Gray's earlier sentiments regarding the RTAP recommendations.

Member Chris Hilbert stated that Jewel Gatling was recently recommended for appointment to the Maggie L. Walker Initiative Citizen Advisory Board and cautioned against appointing persons to multiple boards in the same timeframe.

Vice Chair Gray stated that the commitment is great when serving on multiple boards and reiterated her earlier recommendations of Edward Miller for the resident vacancy and Keith Anthony Turner for the person with a disability vacancy on the Task Force on the Establishment of a Civilian Review Board.

Member Chris Hilbert moved to forward the following appointment applications to Council with the recommendation to approve, which was seconded and unanimously approved:
