

**ORDINANCE/RESOLUTION SUMMARY**

This Resolution request is to appoint Tavares Floyd as the 6<sup>th</sup> District Council Liaison upon completion and favorable outcomes of all pre-hiring requirements for the position.

**BACKGROUND**

Mr. Floyd has been selected to fill the Council Liaison position for the 6<sup>th</sup> Voter District. He has accepted employment conditions as offered pending final appointment by the Council. The effective date of this appointment will be Monday, February 3, 2020.

This request is in accordance with Richmond City Code § 2-2, which states, (a) "The City Council may provide for the appointment of a Council Liaison for each member of the Council to assist the members with administrative support and responding to constituent concerns. (b) Any such Council Liaison shall be appointed by the Council for an indefinite term and shall be a member of the unclassified service."
