Central Virginia Legal Aid Society

Richmond City Council, the governing legislative institution of Richmond, Virginia, in the United States of America, does hereby recognize, honor, and celebrate the Central Virginia Legal Aid Society for its important work as it commemorates its 50th Anniversary.

Established in 1971, the Central Virginia Legal Aid Society is a Richmond-based nonprofit organization that provides free legal assistance in civil matters primarily for people and families experiencing incomes below the federal poverty threshold and those over age 60, even if they do not meet the income qualifications, who cannot afford to hire a lawyer when confronted with legal issues.

Promoting equity, fairness, and equal protection under the law, the Central Virginia Legal Aid Society provides many services, including litigation, briefs, legal advice, negotiation, and representation in administrative hearings, in which it represents thousands of people each year in matters critical to their life needs, such as housing, consumer rights, healthcare, safety, family relations, employment, public benefits, and individual rights.

Earning a solid reputation for its outstanding service over the years, the Central Virginia Legal Aid Society is powered by the hard work and dedication of its Central Virginia Legal Aid Society Board of Directors, Executive Director, Attorneys, Paralegals, Legal Assistants, and its Administrative, Fiscal, Development, and Advocacy staff.

One of the oldest nonprofit legal aid providers in Virginia and created in response to a national movement of establishing nonprofit legal services for civil matters in the late 1960's, Central Virginia Legal Aid Society's history includes a 1981 merger of two Richmond legal aid entities founded in 1971, Neighborhood Legal Aid Society and Metropolitan Richmond Legal Aid Society, and a merger with Southside Virginia Legal Services (Petersburg) and Piedmont Legal Services (Charlottesville) in 2000.

Providing services across a large swath of Virginia, the Central Virginia Legal Aid Society serves people in five cities and 15 counties, with offices in Richmond, Charlottesville, and Petersburg.

Carefully maximizing limited resources, the Central Virginia Legal Aid Society is sustained through a combination of public grants and private donations.

An institution highly respected for its exceptional service, ethics, integrity, and legal expertise, the Central Virginia Legal Aid Society and its staff do not affiliate with a political party, support a specific political candidate, lobby for legislation, or represent criminal clients.

Now, Therefore, Richmond City Council does hereby recognize, honor, and celebrate the Central Virginia Legal Aid Society for its important work on the auspicious occasion of its 50th Anniversary commemoration and thanks its Board, Executive Director, Attorneys, Paralegals, Staff, and supporters for their important legal work on behalf all the residents it serves.
