Appropriating and providing funds for financing the school budget for the fiscal year commencing July 1, 1986, and ending June 30, 1987.

1. THE CITY OF RICHMOND HEREBY ORDAINS:
2. § 1. That a sum not exceeding \$94,342,500 be and
3. the same is hereby appropriated from the general fund, which
4. together with the estimated receipts of the School Board
5. from tuition charges, and from other anticipated sources of
6. revenue of \$2,375,276 the estimated state and federal
7. receipts of the School Board through the Commonwealth of
8. Virginia of \$32,360,157 may be expended for the operation of
9. the public free schools in the City, including the payment
10. of salaries, wages, other expenses, acquisition of equipment
11. and supplies and maintenance of the school plant; provided,
12. however, such expenditures shall not exceed in any event
13. \$129,077,933 but in the event the actual receipts from or
14. through the Commonwealth for the fiscal year commencing
15. July 1, 1986, exceed the estimated receipts from such
16. sources, the expenditure of such excess for such purposes

1. is nevertheless authorized, provided report thereof is made
2. to the Council by the School Board.

3. § 2. That the payment and settlement of claims of
4. any kind heretofore or hereafter asserted against the School
5. Board or the City itself growing out of the operation of the
6. public schools and final judgments heretofore or hereafter
7. obtained against the School Board or the City on account
8. thereof, together with all costs, interest, fees for legal
9. services and all other fees and expenses incident thereto,
10. shall be paid upon the approval and order of the City
11. Attorney from the funds herein appropriated for defraying
12. the expenses of operating the public schools.
