Exterior siding removal and replacement

To Whom It May Concern:

The existing wood siding on this house is in poor condition with many areas that are completely rotted through. I would like to replace all siding on this house using 3/4"x71/2" yellow pine beaded and beveled siding.

The job will involve removal of existing wood siding, installing a moisture barrier using Tyvek or similar product, installing 1/8 wooden battens to allow for air movement behind siding, installing wood siding, primed and painted using a latex exterior house paint of similar color to the existing. We anticipate that some corner boards will need removal and replacement at the time of residing. It is possible that some window sills will also need replacing and these will be replaced using wood lumber cut to match the existing sills. It is possible there is no 3/4" base sheathing on this house, in which case, we would install a 1/2" 4x8 plywood or OSB sheathing to help firm up the structure. (Please see enclosed photographs of current siding which matches the proposed yellow pine siding to be installed).

It is possible some window units, which are not original to the house, would need replacement. If this is needed, it will be carried out with a matching wood window of similar design and size. Your guidance on this would be greatly appreciated.
