Call to Order

Council President Michael Jones called the meeting to order at 6:07 p.m. and presided.

Spanish Interpretation Announcement

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. City Clerk Reid also stated that Spanish interpretation service was available virtually through Microsoft Teams.

Roxana Talavera-Denson, Language Access Coordinator, Office of Immigrant and Refugee Engagement, then provided Spanish interpretation of City Clerk Candice Reid's announcement.

Invocation was offered by Reverend Christy Haga-Turner of Westhampton United Methodist Church, 6100 Patterson Avenue, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

Upon the President's request, Assistant City Clerk Rebecca Sullivan provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

Awards and Presentations

Members recognized that City Council and Mayor Levar Stoney previously proclaimed and established the month of May to be Richmond Older Residents Month.

Council President Michael Jones, on behalf of City Council, and Chief Administrative Officer Lincoln Saunders, on behalf of Mayor Levar Stoney, honored and recognized the Richmond Office of Animal Care and Control and thanked its staff for their involvement with ensuring proper care and safety for animals in the city.

Council President Michael Jones, on behalf of City Council, honored and recognized administrative professionals and thanked staff for their dedication and service to the city. President Jones invited all offices to observe and celebrate the last full work week of April as Richmond Administrative Professionals Week and the Wednesday within that week as Richmond Administrative Professionals Day.

Councilor Stephanie Lynch left the meeting at 6:33 p.m.

Citizen Comment

[CD.2023.147](#) April 24, 2023 Citizen Comment Period Speakers List

Jay Philip Victor addressed Council and stated his concerns with the implementation of rental inspection districts in the city. Mr. Victor also stated that rental inspection districts would be redundant and costly due to previously established codes and regulations related to rental properties.

Monica Esparza, Image Church Renewal of Life Land Trust Trustee, Hickory Hill Preservation Committee Member, RVAgreen 2050 Roundtable Member, addressed Council and stated that surrounding residents of the Hickory Hill Community Center preferred a facility that promoted work force development. Ms. Esparza also stated that computer labs and other renovations occurred to assist with work force training at the community center. Ms. Esparza informed members that she opposed the use of the Hickory Hill Community Center as a Richmond Fire training facility.

Gian Bustillo addressed Council and stated that action should be taken to address housing in the city. Mr. Bustillo also stated that more rental properties should be established in the city to provide more housing options for residents. Mr. Bustillo requested that the city lower the real estate tax rate to compete with surrounding counties to attract potential housing developments.

Elizabeth Barrett, Tree Steward, Urban Forestry Commission Founding Member, addressed Council and requested positive change regarding the city's urban forests. Ms. Barrett noted that the city had plans and legislation in place to promote growth and maintenance of the city's trees. Ms. Barrett also stated that action was needed to implement the desired plans of the city to protect trees.

A copy of the material provided has been filed.

Kendra Esparza-Harris, Doctoral Fellow at the University of Missouri Center for Agroforestry, Serene Wildlife Member, addressed Council and stated that the green space and wildlife surrounding the Hickory Hill Community Center was not suited to support a fire training facility at that location.

Delores Esparza, Former Deerbourne Civic Association President, stated her support for the decisions of the Urban Design Committee and City Planning Commission denying the request to use the Hickory Hill Community Center as a fire training facility. Ms. Esparza requested that the city uphold the decisions of its agencies.

Melody Gray, Deerbourne Civic Association Member, addressed Council and stated that she canvassed her neighborhood regarding the proposed fire training facility, and that 68 percent of respondents opposed the proposed facility at the Hickory Hill Center. Ms. Gray also stated that she did not believe Richmond Fire Department officials provided residents with accurate information regarding the proposed facility. Ms. Gray requested that Council uphold the decisions of the Urban Design Committee and City Planning Commission.

Omari Al-Qadaffi spoke in opposition of ORD. 2023-113, and stated his concerns with the affordability of the apartments referenced in the proposed ordinance.

Elisa Oliver spoke in opposition of ORD. 2023-104, and informed Council of her concerns regarding the impact of the proposed coffee shop on her neighborhood. Ms. Oliver stated that she was concerned about the smell of coffee roasting and the increase in trash.

Geneva Dalton Tyley addressed Council and requested more housing opportunities for residents.

Kevin Vonck, Department of Planning and Development Review Director, provided an introduction and additional background information regarding the proposed ordinance.

Public Hearing

Charles Pool spoke in opposition of ORD. 2023-101, and stated his concerns with the impact on residential neighborhoods in the city. Mr. Pool also stated that the change would make it difficult to install electronic car charging stations in the city.

Joe Gehlbach, Richmond Association of Realtors Vice President of Government Affairs, spoke in support of ORD. 2023-101, and stated that the removal of the parking requirement would help increase the housing inventory in the city.

Barry Greene, Jr., Partnership for Smarter Growth Board Member, RVA Rapid Transit Board Member, spoke in support of ORD. 2023-101, and stated that parking lots should not be prioritized in the city.

Noah Holmes Foster spoke in support of ORD. 2023-101, and he stated his appreciation for the city's outreach and engagement regarding the removal of parking minimum requirements.

Amy Guzulis, Partnership for Smarter Growth Policy Coordinator, spoke in support of ORD. 2023-101, and stated the removal of minimum parking requirements would increase housing inventory and decrease traffic.

Taylor Rule spoke in support of ORD. 2023-101, and stated his appreciation for the information provided to the public by city staff regarding the removal of minimum parking requirements.

William Wilson, RVA YIMBY Member, spoke in support for ORD. 2023-101, and stated, as a vehicle owner without a designated parking spot, he still supported the removal of parking minimums in the city.

Matthew Via spoke in support of ORD. 2023-101, and stated the removal of parking minimums would increase the number of walkable streets and more sustainable methods of travel in the city.

Andrew Bryant spoke in support of ORD. 2023-101, and stated the removal of parking minimums would help increase the amount of affordable housing in the city.

Councilor Andreas Addison addressed the legislative history of ORD. 2023-101, and he stated that he supported the removal of parking minimums. Councilor Addison also stated that the removal of parking minimums for developments would help increase opportunities for shared parking and more available parking for residents and businesses. Councilor Addison provided members with a handout regarding possible outcomes from the elimination of parking minimums.

A copy of the material provided has been filed.

Councilor Katherine Jordan stated that the removal of parking minimums was a debated subject in the 2nd Voter District. Councilor Jordan also stated that shared parking options could help alleviate parking issues in the city.

Councilor Ann-Frances Lambert stated that she supported ORD. 2023-101, and also noted her support for more shared parking opportunities in the city.

Councilwoman Reva Trammell stated her appreciation for the work of colleagues and city administration regarding the proposed ordinance, and she informed members that she supported ORD. 2023-101.

Councilor Cynthia Newbille stated that the removal of parking minimums provided the city an opportunity to address and provide more shared parking in the city. Councilor Newbille informed members that she would vote to adopt the proposed ordinance.

Vice President Kristen Nye stated that the adoption of ORD. 2023-101 could begin the process of the city managing the issue of parking availability in the city.

There were no further comments or discussions and ORD. 2023-101 was adopted: Ayes 7, Addison, Jordan, Lambert, Trammell, Newbille, Nye, Jones. Noes None.

Kevin Vonck, Department of Planning and Development Review Director, provided an introduction and additional background information regarding the proposed ordinance.

Public Hearing

Benny Gates III spoke in opposition of ORD. 2023-103, and stated that he did not believe the proposed development would be allowed in other areas of the city. Mr. Gates informed members that he did not believe the proposed special use permit was fair or equitable.

Will Gillette, Baker Development Resources, spoke in support of ORD. 2023-103, and he provided information regarding the work and goals of ORD. 2023-103 and its applicant, project:HOMES.

Mark Baker, Baker Development Resources Owner, spoke in support of ORD. 2023-103, and stated that the special use permit referenced in ORD. 2023-103 would permit project:Homes to build affordable housing units. Mr. Baker also addressed the legislative history of the special use permit. Mr. Baker further stated he understood that individuals had concerns about the special use permit, and he suggested that consideration of the ordinance be continued to allow for additional discussions to address concerns.

Marion Cake, project:Homes Vice President of Affordable Housing Development, spoke in support of ORD. 2023-103, and stated that the purpose of the special use permit was to allow project:HOMES to construct affordable housing opportunities for residents. Mr. Cake requested additional time for project:Homes to address any concerns from individuals regarding the special use permit.

President Michael Jones informed members of his concerns regarding the proposed special use permit. President Jones stated that he did not support the establishment of a warehouse on a residential street in the 9th Voter District. President Jones also stated his concerns with environmental equity, and that he did not believe project:HOMES engaged enough with the community about the special use permit. President Jones requested that his colleagues support his request to reject ORD. 2023-103.

Councilwoman Reva Trammell stated that she supported the request of President Jones to reject ORD. 2023-103.

Councilor Ann-Frances Lambert stated her concerns with rejecting the proposed ordinance, due to the need for more affordable housing options in the city. Councilor Lambert also stated she supported continuing consideration of ORD. 2023-103 to address concerns.

President Jones confirmed that the location of the proposed development was zoned for residential use, and he stated that a continuance would not impact his decision to reject ORD. 2023-103.

There were no further comments or discussions and ORD. 2023-103 was rejected Ayes 1, Lambert. Noes 6, Addison, Jordan, Trammell, Newbille, Nye, Jones.
