The Honorable Members of Richmond City Council, the governing body of Richmond, Virginia, in the United States of America, do hereby unite in solidarity and common purpose to recognize, honor, and celebrate the Richmond Triangle Players theatre troupe on the auspicious occasion of its 25th anniversary of theatre production season within the Richmond community.

A Richmond-based nonprofit theatre company with a commitment to the celebration of diversity and inclusion, the Richmond Triangle Players performs theatrical plays that explore equality, identity, family, gender, and cultural acceptance through the production of works created by and for the lesbian, gay, bisexual, and transgender community.

Initially conceived as a fundraiser to combat the AIDS pandemic affecting the Richmond community, the Richmond Triangle Players was founded in 1993 after producing an evening of one-act plays with proceeds benefitting the Fan Free Clinic (now known as Health Brigade).

Originally located in the Fieldens Cabaret Theatre, on the top floor of an after-hours night club, after fifteen years of growth, the Richmond Triangle Players toured their productions throughout the greater Richmond community for eighteen months in a variety of venues, including the Gay Community Center of Richmond (now known as Diversity Richmond), Metropolitan Community Church, and the Theatre Gym at Virginia Rep Center, among others. In 2010, the Richmond Triangle Players relocated to the Robert B. Moss Theatre, a 4,000-square foot building on Altamont Avenue, where they are presently located and produce an average of 180 events each year.

Highly regarded for their fine work over the years, the collective repository of awards, honors, and accolades for the Richmond Triangle Players includes the Richmond Theatre Critics Circle Awards for Best Play and Best Musical twice each and more than 90 "Best" nominations; recognized twice by Style Weekly as Richmond's Best Local Theatre Company; named as one of the fifteen most important theatres of its kind in the nation by Playbill.com; and, recognition from Equality Virginia with a 2018 OUTstanding Virginians Award for promoting diversity and inclusion.
