THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That section 12-94 of the Code of the City of Richmond (2015) be and is hereby amended and **reordained** as follows:

**Sec. 12-94. Reservation of picnic shelter [~~and rental fee for picnic packs~~].**

A fee as set forth in Appendix A to this Code shall be charged and paid into the City treasury for the reservation of picnic shelters [~~rental of picnic packs (a duffle bag with games and sporting equipment for use by groups or individuals at picnics) by non-City agencies,~~

§ 2. That the fees set forth in Appendix A of the Code of the City of Richmond (2015) for sections 8-281 and 12-94 of the Code of the City of Richmond (2015) be and are hereby amended and reordained as follows:
