

**PURPOSE:** To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to accept a donation of a 2023 Jeep Wrangler Sport S J23046 valued a approximately \$40, 711.75 from the Friends of James River Park (a Virginia non-stock corporation) for the use of the Urban Ranger Program in the James River Park System (JRPS) and other Park properties.

BACKGROUND: The James River Park System has historically relied exclusively on the Richmond Police Department for enforcement of common transgressions in the Park - off-leash dogs, littering, parking violations, drug and alcohol violations, etc. However, response times can be long to many parts of the Park and locations can be difficult to reach. With the establishment of an Urban Ranger Program, Parks and Recreation anticipates that having two full time Rangers focused almost exclusively on the JRPS will result in more efficient monitoring and enforcement of rules in the Park. The donation

of this Jeep Wrangler will be used by the Urban Rangers to assist them in carrying out their duties pursuant to the Urban Ranger Program.

# Donation and Release Agreement The Friends of James River Park

THIS DONATION AND RELEASE AGREEMENT, effective as of the date of last signature below, is between the City of Richmond, a municipal corporation and political subdivision of the Commonwealth of Virginia (the "Grantee"), and The Friends of James River Park, a Virginia nonstock corporation (the "Grantor"). Collectively, referred to herein as the "Parties".

### STATEMENT OF PURPOSE

- A. The Grantor desires to make a donation to the Grantee in the form of 2023 Jeep Wrangler Sport vehicle, valued at approximately \$40, 711.75 (the "Donation") for use by the Urban Ranger Program in the James River Park System and other City of Richmond Department of Parks, Recreation, and Community Facility properties.
- B. Such donation aligns with the Grantor's mission to care for and make accessible the James River Park System.
- C. Grantee is authorized to accept such donation pursuant to City Ordinance

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantor and Grantee agree:

### 1. Donation

Grantor will provide Donation to the Grantee pursuant to the terms outlined in Section 3 of this document as consideration for the execution of this Agreement. Grantee acknowledges and agrees that it is accepting the Donation on an "as is" basis.

### 2. No Relationship between Parties

The Grantor and Grantee agree that the gift and acceptance of the Donation does not create a relationship of employee, partner, agent, or associate, whether by joint venture or otherwise between the Parties.

### 3. **Terms**

- a. Grantor agrees to provide Donation to Grantee for the express purpose of use by the Urban Ranger Program within the James River Park System and other City of Richmond Department of Parks, Recreation, and Community Facilities properties.
- b. Grantee shall not be responsible for reimbursement of any expenditures made by Grantor in relation to this Donation.
- c. Grantor shall not be responsible for any taxes, fees, or other expenses related to the ongoing care and maintenance of the Donation.
- d. The Donation shall be made in coordination with the authorized representative from the City of Richmond Department of Parks, Recreation, and Community Facilities to determine proper timing and delivery.

### 4. Release

The Grantee shall not be liable for any personal injury or property damage to the Grantor or its agents, contractors, employees, invitees, licensees, officers, or volunteers irrespective of how the injury or damage is caused during the course of the Donation's delivery, and the Grantor hereby releases the Grantee from any liability, real or alleged, for any personal injury or property damage to the Grantor or its agents, contractors, employees, invitees, licensees, officers, or volunteers irrespective of how the injury or damage is caused. Nothing herein shall be construed as a waiver of the sovereign immunity granted to the Grantee by the Commonwealth of Virginia statutes and case law to the extent that it applies.

### 5. Governing Law

All issues and questions concerning the construction, enforcement, interpretation and validity of this Agreement, or the rights and obligations of the Grantor and the Grantee in connection with this Agreement, shall be governed by, and construed and interpreted in accordance with, the laws of the Commonwealth of Virginia, without giving effect to any choice of laws or conflict of laws rules or provisions, whether of the Commonwealth of Virginia or any other jurisdiction, that would cause the application of the laws of any jurisdiction other than those of the Commonwealth of Virginia.

### 6. Forum and Venue

Any and all disputes, claims and causes of action arising out of or in connection with this Agreement, or any performances made hereunder, shall be brought, and any judicial proceeding shall take place, only in the Circuit Court of the City of Richmond, Virginia.
