

AN ORDINANCE NO. 87-236-216

To authorize Shockoe Bottom Farmers and Merchants Association to use the Farmers Market at 17th Street for a Halloween Festival, and to allow sale and consumption of alcoholic beverages (beer only) at said Farmers Market on Saturday, October 31, 1987, between the hours of 8:00 a.m. and dark of said day.

THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. The provisions of Article III, City Markets, of Chapter 7, Business and Business Regulations of the Code of the City of Richmond, 1985, as amended, concerning usage permitted at the Farmers Market at 17th Street in the City of Richmond, and any other applicable provisions of law of the City to the contrary notwithstanding, Shockoe Bottom Farmers and Merchants Association may use the Farmers Market at 17th Street for a Halloween Festival on Saturday, October 31, 1987, to include the sale and consumption of food and beverages (including beer), the sale of crafts and flea market items, and live entertainment, on Saturday, October 31, 1987, between the hours of 8:00 a.m. and dark. Shockoe Bottom Farmers and Merchants Association, as a requisite for

the serving of and the consumption of alcoholic beverages (beer) and conduct of other authorized activities, including the preparation and consumption of food, shall obtain any license and pay any fees which may be required under the laws of the Commonwealth of Virginia and the City of Richmond, and comply with all rules and regulations concerning preparation and dispensing of same. Shockoe Bottom Farmers and Merchants Association shall provide liability insurance, naming the City of Richmond as an additional insured, in an amount of \$1,000,000, obtain the services of such off-duty police officers as may be specified by the Bureau of Police for traffic and other control, and shall comply with all other provisions of law and regulations of the City regarding use of the Farmers Market at 17th Street, traffic and crowd control and food preparation and service, bearing full cost of same as requisite, including the cost of personnel (or persons under contract) of the Department of Recreation and Parks for cleaning the area after the Halloween Festival.

§ 2. This ordinance shall be in force and effect at 8:00 a.m. on Saturday, October 31, 1987, and shall continue in force until dark of the same day.
