#### Call to Order

Chair Stephanie Lynch called the meeting to order at 2:16 p.m., and presided.

# Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the Chair's request, Assistant City Clerk Nahdiyah Muhammad provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

# **Public Comment Period**

Kimberly Dale spoke regarding her current experiences as a homeless individual with health needs. Ms. Dale requested more access to public restrooms and stated it was a public health issue.

Savanday Brown spoke regarding her previous comments provided to the committee regarding the city providing a building to use as a shelter space, instead of allocating funding to different organizations.

Bridgette Whitaker spoke regarding the need for a centralized database to track clients and organizations that are receiving federal and state funding to provide shelter.

Nancy Williams stated her appreciation for shelters in the city and the staff that run the facilities. Ms. Williams also stated that more police were needed at the shelters located along the Midlothian corridor due to high drug activity. Ms. Williams further stated that she would like assistance from the city to make Tabernacle of Praise Ministries a water and cooling station.

Rhonda Sneed, Blessing Warriors Executive Director, addressed overdoses that are occurring at temporary shelters. Ms. Sneed stated that the resources to feed, clothe and provide programs for the homeless population in the city are not enough.

Chair Stephanie Lynch gave appreciation to individuals that provided comment to the committee. Chair Lynch stated the next report that will provide an update on inclement weather shelters will be September 14, 2023.

## Discussion Item(s)

#### **Violence Reduction & Out of School Update**

Jason Kamras, Richmond Public Schools Superintendent, provided the committee with an update regarding the development of a 15-point plan to address violence and absenteeism.

Chair Stephanie Lynch inquired about the recommendations to come forward regarding the 15-point plan.

Superintendent Kamras stated that the Richmond School Board is attempting to fund as much as possible with the available grants. Mr. Kamras also stated that the most recent report from the Joint Legislative Audit & Review Commission (JLARC) states that Virginia significantly under funded K-12 schools.

Chair Lynch inquired about additional staff positions that will need funding.

Superintendent Kamras stated that between 30-40 positions will need funding, which can be funded by grants next year. Mr. Kamras also stated that the grants will expire and reoccurring funding will be needed in the future to maintain the positions.

Member Andreas Addison stated Richmond Public Schools budget has increased by \$62 million since 2017. Member Addison also stated that the increase is to help maintain and keep up with the needs of Richmond Public Schools. Member Addison further stated it may seem like a large increase but the increase in funding for Richmond Public Schools was long overdue.

Nicole Jones, Richmond School Board Member, stated that the 200 school day pilot will begin July 24th for Cardinal Elementary and Fairfield Court Elementary Schools.

Superintendent Kamras had continued discussion with committee members regarding Richmond Public Schools.

#### **Children's Budget Update**

Eva Colen, Manager of the Office of Children and Families, and Joyce Davis, Council Policy Analyst, provided the committee with an update regarding the Children's Budget. Ms. Colen stated that the work resulting from the Fiscal Mapping project will help create a Children's Budget. Ms. Colen also stated that the project will track how local funding flows to various services for school aged children, beginning in early childhood to grade 12.

Joyce Davis, Council Policy Analyst, stated that the data collection aspect of funding will be provided after more has been collected and processed.
