THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. That Section 16-2 of the Code of the City of Richmond, 1985, be amended and reordained as follows:

Sec. 16-2. Districts created; boundaries of districts.

In order to execute the purposes and objectives declared in section 16-1 of this code and pursuant to the powers granted to and conferred upon the city in section 15.1-503.2 of the Code of Virginia and section 17.10 of the Charter, there is hereby created in the city and it is hereby divided into certain districts to be known as "Old and Historic Districts", which are hereinafter referred to as such in this chapter, and which shall be in addition to the districts into which the city is divided by chapter 32 of this code. The boundaries of such districts are as follows:

Joseph P. Winston House Old and Historic District

The Joseph P. Winston House Old and Historic District shall consist of the area beginning at the point of intersection of the east right of way line of First Street with the south right of way line of Grace Street; thence easterly along the south right of way line of Grace Street a distance of 64.65 feet, more or less, to the east property line of parcel W000-0063-002 (number assigned by Assessor of the City of Richmond for tax purposes); thence southerly along the east property line to the south right of way line of a 22.16-foot east-west alley between Grace Street and Franklin Street; thence westerly along the south right of way line of the alley to the east right of way line of First Street; thence northerly along the east right of way line of First Street to the beginning point.

§ 2. This ordinance shall be in force and effect upon adoption.
