I hope you're doing well and had a good summer.

I wanted to let you know that the plans for the Garden House at 1 Calycanthus have changed slightly from the plans that the Windsor Farms Architectural Review Committee approved earlier this year. The revised plans are attached. As the committee will see, the principle differences from the last drawing are that (i) the structure will now be square rather than octagonal, (ii) the roof design is simpler, and (iii) the height is lower by ~3 ft.
