Dear Ms. Glasser:

Thank you for the opportunity to submit this application for a "Black Lives Matter" mural to the Public Art Commission.

Venture Richmond's mission — to engage business and community leaders in partnering with the city to enhance the vitality of the community, particularly downtown, through economic development, marketing, promotion, advocacy and events — is more important today than ever. Recently, important protests of systemic racial injustice—compounded by the COVID-19 pandemic — have challenged many of our downtown businesses, especially those in the East Broad and East Grace Street corridors. This public art opportunity is two-fold: a chance to engage the public in a movement that affects our city, our region and our nation, and to encourage solidarity and continued support for the city's Black community who have contributed to the fabric of Richmond for centuries. Whether serving as labor to dig the city's canals, laying the bricks to construct the Capitol or establishing Jackson Ward as the "Harlem of the South," our city was "Built by Blacks."

Richmond, a southern city with a complicated history, is still grappling with that history today. In other cities, these murals have served as new gathering spaces in recent months. The Black Lives Matter movement is "committed to struggling together and to imagining and creating a world free of anti-Blackness, where every Black person has the social, economic, and political power to thrive." In Richmond, many organizations continue to work toward changes to uplift and expand access and inclusivity, and ultimately create greater equity. This proposed mural offers an opportunity to create a significant public space and to partner with the broader community to execute. We look forward to engaging the community in this process. This space will allow time for dialogue and reflection, conversation and long-term programming as has been demonstrated nationwide in other cities. It seems fitting to add to the history of Richmond that occurred within blocks of this site. From Ku Klux Klan marches to Emancipation Parades, to the signing of Massive Resistance and segregation legislation to the inauguration of the nation's first-elected Black governor at Capitol Square, to Lenten interfaith conversations at nearby churches and recent demonstrations, the intersection of 9<sup>th</sup> & East Grace Streets has its own story to tell. This effort will be one small step in furthering the cause and engaging community.

# PROPOSED INSTALLATION START DATE

<u>Please note:</u> The combined approval process by the Public Art Commission and the Planning Commission will take a *minimum* of four weeks from the time the fully completed application is submitted. Installation cannot begin until a final approval has been granted and all City permits have been secured.

Mid-August to early-September pending city permits and approval.

#### PROPOSED DURATION OF THE PROJECT

The project should take 5 days to paint/install which includes: 1 day for power washing; 1 day for layout/stenciling; and 2-3 days painting 2-3 coats.

#### PROJECT INFORMATION:

#### Describe the project (include materials list)

June 2020 brought demonstrations, protests and vandalism to downtown Richmond following the murder of George Floyd, at the hands of a police officer, in Minneapolis and continued police brutality aimed at Blacks throughout the nation. Businesses on the E. Broad and E. Grace Street corridors and on adjacent side streets downtown brought further attention to tensions of Richmond's complicated history of enslaved Africans, the Civil War, Reconstruction, Jim Crow and Civil Rights' eras to the present day. Venture Richmond seeks to bring further attention to the Black Lives Matter movement in an effort to demonstrate support and to show solidarity with other major downtowns such as Minneapolis, MN; Charlotte, NC; Washington, DC; Denver, CO, Seattle, WA; Tulsa, OK; Brooklyn, NY; and soon Baltimore, MD. We would like to join this list of trailblazers, while encouraging more people to continue to come downtown. With so much attention on our history, the recent removal of many monuments dedicated to leaders of the Confederacy, and existing support of downtown businesses already displaying "Black Lives Matter" on their storefronts, it seems like no more perfect time to make this more permanent display of solidarity. The mural would be painted on the 800/900 block of E. Grace Street near St. Paul's Episcopal and St. Peter Catholic Churches; the Barbara Johns Building (location of the state's Office of the Attorney General.) Materials: Sherwin Williams Heavy Shield Paint, Yellow

# Rationale for placing the art on public property

The Black Lives Matter Mural would be a way to demonstrate external support to Richmond's broader community, especially the Black community, and show that many stand with them in support of an end to racial inequality and injustice and to encourage efforts toward equity and inclusivity. The 800-900 block of E. Grace Street is preferred, near the Virginia State Capitol/Capitol Square, a half block from Richmond's City Hall, and adjacent to St. Paul's Episcopal Church. The state's Office of the Attorney General/Barbara Johns Building, St. Peter Catholic Church and the Federal Courts Building also line this block. The area offers a varied history near buildings that house both state and local government and offers the chance for many passersby to encounter the artwork and visit other public art at the Capitol Square. "Jefferson's Capitol" and exterior grounds have welcomed Civil War generals, the first African Americans to hold office in Virginia, served as the backdrop to major motion pictures, and celebrated the nation's first-elected Black governor. Pedestrian traffic in this area is strong, especially on days of worship as well as during the General Assembly Session.

### Describe the artist's qualifications/credentials

Hamilton Glass is a native of Philadelphia, "Ham" has been engaged in art since he was a young child, where he began taking classes at the Philadelphia Institute of Art. He earned his BA in Architecture at Hampton University and went on to work for various firms in Virginia and New Jersey. Locally, his art has been featured in public murals throughout the city; a 2019 installation at the Virginia Museum of History & Culture, the 2018 Richmond Folk Festival poster artist. Hamilton also dedicates a lot of time teaching and engaging youth in participating in his mural painting projects as volunteers and served as a program leader with youth at Art180 from 2009-2014. Ham is inspired by public art and the way it both influences and inspires the surrounding community. Hamilton is currently working on a project, "Mending Walls," which engages the public with conversations regarding race/ethnicity/inclusion, tying directly into the BLM movement.

Ed Trask moved to Richmond to enroll into the VCU's painting program. While at VCU, he spent hours hour playing music in the mid 80's punk scene and painting. After many attempts to get gallery attention, he decided to use dilapidated buildings as his canvases, painting directly on buildings or on boards and screwed onto the buildings illegally. In 1992, Ed graduated with a painting degree and moved to Washington D.C. where he started touring with a band, the Holy Rollers, and continued to paint illegal murals all over the world. Three years later he moved back to Richmond to join the band Kepone. While the demand for his paintings started to grow, he figured he should start a gallery and make a go at mural and sign work. Since then the work has never stopped flowing in, and Ed's paintings and murals have been collected into many permanent collections including Gap, Capitol One, Dominion Energy, Fortune Magazine, N.B.C. Philip Morris, Media General and Play inc. Ed continues to have art shows worldwide and has his studio in Richmond where he lives with his beautiful wife and two children.

### Installation plan

A group of Venture Richmond staff, artists, business owners, and community volunteers will come together to bring this mural to life. The collection of artists will be led by muralists Hamilton Glass and Ed Trask, both of whom have been approved previously for murals throughout the city, specifically downtown. Streets will be power washed in advance (day 1); then, teams will gather to layout mural stencil, then engage teams in painting letters. The plan is to complete the mural in 5 days or less to minimize street closures and to do so when so many downtown employees continue to work from home. Business owners and many artists are eager to get to work and have already voiced support of participating as they have in many downtown efforts. All participants will practice social distancing as mandated by the Governor/Commonwealth of Virginia and City of Richmond.

## Proposed maintenance plan

When this mural needs maintenance, Venture Richmond will work with the artists and volunteer community to do so annually at our own cost. Should the mural fade and need to be removed, we will coordinate with the city to do so with advance notice to neighboring institutions. Should the mural need to be replaced for any reason; Venture Richmond staff will coordinate that as well.

Applications must be submitted at least 10 business days in advance of the next available PAC meeting. These meetings are schedule on the 4<sup>th</sup> Thursday of most months.

#### WHAT HAPPENS NEXT:

#### PAC Review and Recommendation


The PAC reviews your proposal at the first available Commission meeting. You are welcome to present your proposal in person at the meeting and answer any questions posed by Commissioners (though you are not required to attend). Following a discussion, the PAC either (1) recommends the proposal, (2) recommends the proposal with contingencies (meaning you may need to make specified modifications to the proposal), or (3) rejects the proposal. The PAC then passes the proposal and its recommendation on to the Planning Commission for a final decision.

# Planning Commission Approval


The Planning Commission reviews the proposal at their next available meeting following PAC action. The Planning Commission meets the first and third Monday of the month. You are not required to attend this meeting but you may wish to attend to address any Commission questions. The Commission then votes to approve or reject the proposal.

### Installing the Art

After receiving a final approval from the Planning Commission—but before installing the art—you are responsible for securing any needed City permits such as work in street permits or electrical/plumbing/structural inspections to ensure the installed art complies with all City regulations and necessary safety and structural precautions.
