THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. The provisions of Article VIII of Chapter 9 of the Code of the City of Richmond, 1985, concerning sale of merchandise in the public parks of the City of Richmond and any other applicable provisions of law of the City of Richmond to the contrary notwithstanding, the Church Hill Association may use Libby Hill Park for the Church Hill Neighborhood Celebration "High on the Hog" on Saturday, October 10, 1987, may sell and consume alcoholic beverages (beer), present live entertainment (playing of music on stage from 1:00 p.m. to 7:00 p.m.), and may prepare or have prepared and sell barbecue in said Libby Hill Park on Saturday, October 10, 1987, between the hours of 10:00 a.m. to 8:00 p.m. The Church Hill Association, or other group meeting the requirements of the Virginia Alcoholic Beverages

Control Board, as a requisite for the sale of beer, shall obtain any license which may be required under the Alcoholic Beverage Control Act of the Commonwealth of Virginia. The Church Hill Association shall provide liability insurance, naming the City of Richmond as an additional insured in an amount of not less than \$1,000,000 and shall comply with all other provisions of law and regulations of the City regarding use of public parks, traffic and crowd control bearing full cost of same, and tax and similar laws of the City as a requisite for obtaining permission for such usage.

§ 2. This ordinance shall be in force and effect at 10:00 a.m. on Saturday, October 10, 1987, and shall continue in force until 8:00 p.m., on Saturday, October 10, 1987.
