### Call to Order

Council President Michael Jones called the meeting to order at 6:04 p.m. and presided.

### Spanish Interpretation Announcement

City Clerk Candice Reid stated that Spanish interpretation service was available in the Council Chamber and that attendees should speak with a representative to receive the appropriate equipment. City Clerk Reid also stated that Spanish interpretation service was available virtually through Microsoft Teams.

Roxana Talavera-Denson, Language Access Coordinator, Office of Immigrant and Refugee Engagement, provided Spanish interpretation of City Clerk Candice Reid's announcement.

Invocation was offered by Father Nicholas Bacalis of Saints Constantine and Helen Greek Orthodox Cathedral, 30 Malvern Avenue, Richmond, Virginia.

Members of Council and the audience recited the Pledge of Allegiance.

### Chamber Emergency Evacuation Plan Announcement and Citizen Speaker Guidelines

Upon the President's request, Assistant City Clerk Nahdiyah Muhammad provided information on the appropriate manner in which the Council Chamber is to be evacuated in the event of an emergency along with citizen speaker guidelines.

## Citizen Comment

[CD.2023.190](#) May 22, 2023 Citizen Comment Period Speakers List

Melvin Jones addressed Council and stated his concerns regarding the Department of Emergency Communications 911 emergency response time. Mr. Jones informed Council that he had difficulty alerting public safety entities about a shooting on his block due to phone prompts that required he provide certain information.

Ted McGarry addressed Council and stated his concerns regarding RES. 2023-R006 and the creation of future rental inspection districts in the city. Mr. McGarry informed Council that he was concerned new rental regulations would increase the cost of operating rental properties and increase rental rates in the city.

*Councilor Stephanie Lynch stated that no rental inspection program was in effect, and that city administration was still in the process of collecting recommendations related to RES. 2023-R006. Councilor Lynch also stated that the intent of a rental inspection district was to address the operating of multi-family rental units with unsafe living conditions.*

Angela Johnson addressed Council and stated her concerns regarding the conditions of her neighborhood. Ms. Johnson also stated that it was a struggle to maintain her home due to the cost of real estate taxes in the city. Ms. Johnson further stated that she did not believe she was receiving adequate city services based on the taxes she paid.

*President Michael Jones informed Ms. Johnson that city administration would review and address her concerns.*

Cheryl Nici-O'Connell, Richmond United for Law Enforcement, addressed Council and stated her concerns with public safety challenges. Ms. Nici-O'Connell also stated that the community needed to take responsibility and collaborate to improve public safety.

Joe Domino addressed Council and stated his concerns with an advertisement for a Dragstravaganza event in the city. Mr. Domino informed Council that he did not believe the event was appropriate.

*President Jones stated that Council would not tolerate any comments that demean any person in the city.*

*Councilor Katherine Jordan stated she was disturbed by Mr. Domino's comments, and she stated her support for the organizer of the Dragstravaganza event.*

Lawrence Meyer addressed Council and stated his concerns with the Vision Story referenced in the Richmond 300 Master Plan. Mr. Meyer also addressed his recommendations for amending the Vision Story.

Jeremy Davis addressed Council and stated his opposition to the establishment of a resort casino in the city. Mr. Davis also stated that he believed the idea of a casino was rejected when the city's prior referendum to select a preferred casino gaming operator failed.
