Chair Andreas Addison called the meeting to order at 3:10 p.m., and presided.

Rental Inspection Program Timeline

Kevin Vonck, Department of Planning and Development Review Director, provided the committee with a presentation regarding the Residential Rental Inspection Program (RRIP) timeline. Director Vonck also addressed potential issues and concerns regarding the program. Director Vonck also provided his recommendations regarding the RRIP.

Vice Chair Ellen Robertson stated it was important for the city to ensure safe living conditions for city residents, but the city needed to create a program that produced productive results and did not harm the city's affordable housing inventory. Vice Chair Robertson also addressed the relationship between a tenant and renter that might be impacted by establishing a RRIP. Vice Chair Robertson further stated her concerns about a RRIP leading to more evictions in the city.

Chair Andreas Addison inquired if the Department of Planning and Development Review would require additional staffing to administer a RRIP.

Director Vonck stated that no additional staffing was requested for the RRIP.

Vice Chair Robertson again stated her concerns about a RRIP impacting the availability of affordable housing rental units in the city.

Councilor Stephanie Lynch left the meeting at 4:02 p.m.

Safe and Healthy Streets Commission Presentation

Louise Lockett Gordon, Safe and Healthy Streets Commission Chair, provided the committee with a presentation that addressed transit and pedestrian infrastructure improvements in the city, commission recommendations for increased safety, and upcoming meetings of the Safe and Healthy Streets Commission.

Sherrill Hampton, Department of Housing and Community Development Director provided the committee with a presentation that addressed the city's performance grants process and requirements.

Chair Andreas Addison addressed rebates and tax incentives used in the city's grant process for affordable housing construction, and he stated that he believed the method saved the city money by incentivizing other entities to lead the construction and development of affordable housing units in the city.

Vice Chair Ellen Robertson addressed tax abatement programs in the city, and she stated that the programs are beneficial tools if used correctly, but must avoid disenfranchisement of minority populations in the city.

Director Hampton provided the committee with additional information that detailed how the Department of Housing and Community Development collaborates with other city departments to increase affordable housing production and preservation.

Chair Addison requested that Director Hampton provide the committee with a future presentation that addressed affordable housing development not dependent on the city's grant process.

Vice Chair Ellen Robertson also requested a future presentation that provided specific details regarding the city's \$50,000,000 bond financing program for affordable housing development and the consequences of the increased debt.
