A motion was made by Committee Member Clarke, seconded by Committee Member Woodson, that this Location, Character and Extent Item be recommended for approval with amendments to the Planning Commission.

**Recommended Conditions of Approval:** 

• Staff recommends approval of the proposed application, contingent upon the applicant obtaining all necessary permits and approvals from the appropriate city departments and agencies.

• Staff recommends that final paving surface materials prioritize permeability where possible to mitigate the negative effects of stormwater runoff and the urban heat island effect.

• Staff recommends that the applicant include additional site features that would enhance increased connectivity in the final design, specifically by incorporating additional bicycle parking and/or bike racks in front of the western entrance of the school.

• Staff recommends that the applicant explore planting options along Whitehead Rd., specifically looking to include opportunities to plant mature trees.

• Staff recommends that the applicant explore the feasibility of including additional streetscape elements, specifically street lighting along Whitehead Rd. where possible
