Call to Order

Chair Andreas Addison called the meeting to order at 2:04 p.m., and presided.

DEPARTMENT OF PUBLIC UTILITIES

The following ordinance was considered:

1. [ORD. 2022-375](#) To repeal Ord. No. 97-105-173, adopted May 27, 1997, which established a street light policy for the City of Richmond.

Continued to the April 27, 2023 Land Use, Housing and Transportation Standing Committee meeting

Torrence Robinson, Department of Public Works Deputy Director of Operations, introduced the ordinance. Mr. Robinson presented the committee information regarding the current streetlight policy and stated that the department had plans to modernize the current standards and policies pertaining to streetlights in the city.

Chair Andreas Addison shared his concern that there was no clear streetlight policy replacement available to enact if the current policy was repealed.

Vice Chair Ellen Robertson inquired about when a replacement streetlight policy could be introduced.

M Khara, Department of Public Works Deputy Director and City Engineer, shared information on when the replacement streetlight policy could be completed.

Mr. Robinson shared information on the reasoning behind replacing the original streetlight policy and the need to repeal the ordinance.

Bobby Vincent, Director of the Department of Public Works, explained the original ordinance would need to be repealed in order to begin the implementation of a modernized streetlight policy. Mr. Vincent stated a replacement plan could be presented by the upcoming April committee meeting.

There were no further comments or discussions and Vice Chair Ellen Robertson moved to continue ORD. 2022-375 to the April 27, 2023 Land Use, Housing and Transportation Standing Committee, which was seconded, and approved: Ayes 2, Addison, Robertson. Noes None.

2. [ORD. 2023-054](#) To authorize the Chief Administrative Officer, for and on behalf of the City of Richmond, to execute an Agreement between City of Richmond and Commonwealth of Virginia, Department of Transportation for Adjustment of Water and Sanitary Sewer Facilities, for the purpose of setting forth the water and sanitary sewer facilities adjustments associated with improvements to the intersection located at U.S. Route 1 and Hopkins Road.

Jonathan Cosby, Department of Public Utilities Principal Engineer, introduced the ordinance. Mr. Cosby shared information on the improvements to the sewer facilities that would be performed by the Virginia Department of Transportation.

Department of Transportation and Safer Streets

Vice Chair Ellen Robertson suggested that Council could invest in more analysis to help determine which actions the city could take to influence changing the behavior of drivers.

Bobby Vincent, Director of the Department of Public Works, shared information on how the Richmond Police Department and Department of Public Works were collaborating in hopes to design a speed management program to address safety in the city.

Fall Line Trail and Bridge Projects

Chair Andreas Addison requested updates or timelines on the projects in order to share the information with the public and prepare Council for budget decision making.

Vice Chair Ellen Robertson inquired on whether the Finance and Economic Development Standing Committee should be included in tracking and management of the construction projects.

Chair Addison suggested discussing the information further at a future date.

Land Use, Housing and Transportation Committee future retreats

Chair Andreas Addison shared his desire to develop an informal setting in which Land Use, Housing and Transportation Committee members, city administration, and others could spend time discussing policy goals.

Vice Chair Ellen Robertson shared her support for the possibility of attending an informal meeting and proposed developing a quarterly plan to meet.

Chair Addison shared his support for the quarterly meeting plan.
