My name is Joey Elswick and I am an avid supporter of the Camel, a resident of the city's Second District, and most importantly, a tax payer. When I chose to move into the city of Richmond, I knew there were certain things I would have to deal with in my living environment on a daily basis. I write to you today to urge you to adopt the Special Use Permit sought by the Camel to extend its hours of operation beyond the proffers currently in place. The matter is currently set to be heard by the City Planning Commission this Monday.

Since its inception, the Camel has been a responsible corporate citizen. ## Good Morning Richmond,

I would like to personally respond to Mr. Scudder's letter below.
The West Grace Street Association has already sent two letters of support for the changes to The Camel's' SUP, as did the FDA. We're done. We are all just beating the same dead horse at this point.
I would like to address some of these complaints because most of them have nothing to do with the change in hours and most of these go back many years yet the person complaining here had nothing to add to the WGSA discussion for six months and other than to request the employees not prop the door open as the noise would penetrate the back of the building and could be heard from the alley. I immediately addressed with Mr. Burgess and he has distributed keys to employees to use when recycling and removing trash so they don't have to prop the door open. No mention was ever made of the trash issues by this resident. Another resident asked if he could keep the garbage behind the fence. In this conversation we discovered Mr. Shorkey had circulated a flyer with photos of overfull garbage cans, behind the fence but he could see from his second floor window; welcome to the city Mr. Shorkey, we can all see trash cans from the back of our buildings, most of them overflowing from multi-family dwellings that don't buy their own cans so they fill everyone else's, it stinks but doesn't make you special. We also discovered from the photos that half the trash in the cans was not even from The Camel, the neighboring buildings were filling his cans. Mr. Burgess has a engaged a private company to do multiple pickups and is working on making the rear of the property better. The reference to rats is just blustery rhetoric as the health department report says no evidence of rodents. You can't allow a resident who had no issues for years, to suddenly decide he has had an issue for years, it just doesn't work that way. All of the issues here are fixable and have nothing to do with the request to change the hours. This should be an opportunity to discuss how we do business in the city of Richmond. I am not in any way trying to disparage Mr. Scudder. He has been a good neighbor. I believe he is unnecessarily fearful and part of this fear stems from YOUR action; when you decided to have one designation for all late night food/music businesses, the "Nightclub" designation, you created a new kind of fear. Mr. Burgess doesn't consider himself to be a nightclub, the neighborhood doesn't consider his business a nightclub, Tom Griffin put it best when he said, it's a music hall, plain and simple. I believe Mr. Scudder is worried the label nightclub will hurt his property values. As a real estate professional, I totally disagree, and we have the market activity and comparables to prove that, but Mr. Scudder and I simply disagree and we are both entitled to our opinions. RICHMOND CITY: Perhaps when you are considering future designations, you would be smart to not try to group everything into one category....a duck is not an orange. All of the issues described by Mr. Scudder are part of urban commercial activity and are going to be part of our landscape from now on so yes, we should be having a continuing conversation about how to make changes and improvements. We can continue to allow and encourage individual property owners to constantly halt the process or we can have a productive discussion about how to not arrive at this reality over and as we see West Broad Street continue to become a destination; most folks are excited about the changes but there will always be a few people that are scared to death of any kind of development or change and unfortunately, those folks have occasionally held us back. One property owner shouldn't get to NOT have any issue or complaints for YEARS and then suddenly claim you have actually had years of issues, it's disingenuous and totally unproductive. RICHMOND CITY: YOU are a huge part of the problem. Rex is right
about one thing, enforcement has been sporadic at best and that applies everywhere including the residential side where multi family properties are more often the problem with garbage, parking, and noise issues, though that too is changing and has gotten better. Also, VCU Police enforcement activity is AWESOME and has really assisted in the transformation of West Grace Street so it is totally possible to make reasonable rules and enforce them. I have had lots of homeowners that would like to see a new requirement added to O H requiring multi-family properties to convert to single family when a sale or transfer of title occurs but that would be unfair and would likely mean many multi-family owners would be unable to easily sell their properties due to the economic burden of returning multi family to single family; we SHOULD NOT make policy that harms individual owners either residential OR commercial, it's discriminatory and leads to unequal application of the laws that should protect everyone. There are plenty of uses that are prohibited by zoning, this isn't one of them and we have allowed EXACTLY this accommodation at other locations on West Broad, many before the Camel, some after. West Grace Street hasn't approached change with a gentrification mindset; we appreciate all our residents whether they are single family owners, tenants, or residents of group homes. It doesn't matter whether you have lived her 40 years or 40 days, everyone's opinion matters. We're not here to eliminate anyone from the neighborhood and feel everyone has something positive to offer our community and the greater community does include West Broad Street. As a neighborhood, we are not too happy that Mr. Shorkey didn't ask for approval to change from a tanning salon to a "hot yoga" provider as the parking need is decidedly different for yoga classes than for the single folks that park and walk up to tan. However, if that is what Mr. Shorkey needs to do to generate income, we'll not likely attack him as we understand the need to have adequate income, regardless of what the parking requirements might be. We're getting ready to discuss some multi use development on Broad and Lombardy, same deal with parking but we recognized the need to be reasonable.
What can we do differently? RICHMOND CITY: When you permit restaurant businesses, please make multiple day trash pickup mandatory. Waste management is totally incapable of serving commercial customers adequately and as we have space issues, the number of cans actually needed to serve these customers often won't fit into the alley. The photo of Mr. Burgess trash is a joke as I once sent a photo of what is now the amazing Pig \& Pearl (two dumpsters) but was the not so amazing Cabo's and they had dumped 40 bags of maggot infested trash onto the ground in the alley and the health department said there wasn't much they could do about it so Mr. Brugess full cans, behind a fence (now addressed) were far superior to the rest of the city and will now hopefully cease to be a recurring issue. I took a drive down the alley behind WG, all the way downtown and what I saw was block after block of garbage cans over full, many kicked over and garbage all over the alleys,. This is a city waste problem that should be addressed on a large scale, not as a gun to the head of individual business owners when their residential neighbors have an issue.
When you permit residential development in a commercial district, have guidelines for noise insulation so you don't have residents complaining. It will be more expensive but guess what, so is replacing your windows in an O H district. Personally, if you choose to live in a commercial district, you shouldn't complain but as we see, there is always one angry person who will ruin it for everyone else. Also, please address the parking issues in Richmond or just admit it is a problem and move on. If parking is going to be the go-to complaint for EVERYTHING, you should cease the permitting of anything else, residential or commercial and we should just turn off the lights and leave town but you SHOULD NOT punish one business or resident for parking issues as that is a reality in everyone's bag of nails; we are either going to permit or just be happy with vacant buildings.

We had fifty or so residents show up at our last porch party and one homeowner had a thought and some advice to relay to Mr. Burgess. He said maybe Rand should play the same get even game, forget about the change to the SUP, just stay with the current one, don't break the rules and open a Biker Bar, it's allowed, no changes needed. Personally, I would rather not have a biker bar and would like to create rules and guidelines under which he can be successful in his current capacity and continue to be an asset to the neighborhood. Reasonable rules and guidelines, enforcement, and voila, awesome options for the neighborhood, issues addressed, a commercial neighbor that wants to be a part of the neighborhood and cooperate, doesn't get much better than that!

Last (and I am so done with this issue), a single land baron, neighbor, or developer should not get to decide for everyone else, nor should a man with a personal vendetta. This is a city. If you want to live in a neighborhood where the sidewalks roll up at 10 pm and your neighbors tiptoe through the tulips, move to Ashland where you get that reality. However, don't go to Ashland and then complain about the train as that would be idiotic, just as moving to West Broad Street and complaining about restaurant, traffic, and street noise would be. If we all work together we really can solve these issues as a city; if we keep making policy based on single location, we will constantly be needing to have these mindless discussions about how much noise the angels dancing on the head of a pin, can actually hear. This is no way to run a city.
Still supporting the change in SUP

To Whom It May Concern:
I am writing in support of the requested changes to the Camel's SUP. I have also spoken to those residents that back up to Rand that are in the WGSA and there are additional letters of support coming directly from those residents accompanying this letter. Some neighboring residents have asked to speak on his behalf at any future hearing. If we can't be flexible and fair, we will never be successful. The current SUP was crafted many years ago when most of WB was empty, derelict buildings so I understand why there were extra precautions taken. However, those days are over and the current SUP places a decidedly discriminatory and burdensome set of restrictions on Mr . Burgess that are not uniformly applied to other similar venues on West Broad Street. Some of these requirements actually pose a hazard as Mr. Burgess is required to take his patio fencing down every night so it is not secured to the ground (nobody else is required to do this). We should have a single standard for everyone that is in a like-kind location with specific requirements for differing building types and corner properties. We should enforce the rules in an equitable, uniform manner and protect every resident and business. If someone is breaking the rules there should indeed be a punishment but we can't have different standards for every block and sometimes even every address. There is no difference between the 1600 block of West Broad and the 2000 Block of West Broad yet the Republic had an SUP that allowed live music and a $2 a m$ closing time. Emilio's has is a music centered venue that is another huge asset tot he neighborhood and they have a $2 a m$ closing time. The Camel goes to great lengths to ensure music doesn't bother the neighbors, the business is appropriately operated and the owner present most of the time, but he is required to close early...it doesn't make much sense. If Mr . Burgess is allowing noise to disturb the quiet of the neighborhood I would be the first person to call him and tell him to make it stop, and as he has exhibited in the past, he listens and comes up with strategies to fix issues. I am not suggesting we allow nonsense, just be fair and stop operating our city through squeaky wheel politics and procedures.

Mr. Burgess has created a unique model at this location that provides a forum for local up and coming musicians to perform and is an excellent option for good food AND music for the neighborhood; many of our residents have even taken their kids and grandparents to Bluegrass Friday nights from $6-8 \mathrm{pm}$ as this is actually a pretty family friendly venue during the early hours.

West Broad Street is commercial, period. We would definitely draw swords over any kind of car lot, pornography or strip club but we strongly encourage positive development and well run options for the neighborhood. Rand Burgess has always supported the neighborhood and the association and we all have a vested interest in appropriately run, successful business ventures landing and staying on West Broad. Let's not put Rand out of business only to give permission to the next tenant/owner (which is a likely scenario). Let's try to create an atmosphere that leads to success for everyone!

## Regarding The Camel's SUP application

I am writing in support of the requested changes to The Camel's SUP. I have spoken to those residents that back up to The Camel that are in the WGSA and there have been additional letters of support that have been sent to planning directly from those residents. After 6 months and many conversations and emails with one owner, Rex Scudder, who initially had only a couple of minor issues, not related to the SUP change that he wanted me to address with Mr. Burgess (as was done) Mr. Scudder has, in the last two weeks, decided to work with Mr. Shorkey, the owner of Fan Tan and of course he has every right to do so. On Monday May $19^{\text {th }}$, we gave Mr. Scudder the opportunity to share his personal concerns as well as to act as agent for Mr. Shorkey at the May WGSA board meeting. Several 1600 block neighbors some of whom have offered support for The Camel's change in SUP were present as well as the always present representatives form VCU police, Greg Felton and RPD, Officer Ward Kuper. Mr. Scudder was to have 10 minutes to share and we allowed him an hour and a half but he was unable to share any compelling concerns related to the SUP change so the WGSA a second time voted to support The Camel's requested changes. Some neighboring residents have asked to speak on behalf of the Camel at the planning hearing in June. This is in no way meant to be disrespectful to Mr. Scudder, he is a good neighbor and we appreciate his input and will continue to work on other issues in tandem and on his behalt.

If we can't be flexible and fair, we will never be successful. The current SUP was crafted many years ago when most of $W$ Broad consisted of empty, derelict buildings so $I$ understand why there were extra precautions taken. However, those days are over and the current SUP places a decidedly discriminatory and burdensome set of restrictions on Mr. Burgess that are not uniformly applied to other similar venues on West Broad Street. Some of these requirements actually pose a hazard as Mr. Burgess is required to take his patio fencing down every night so it is not secured to the ground (nobody else is required to do this). We should have a single standard for everyone that is in a likekind location. We should enforce the rules in an equitable, uniform manner and protect every resident and business. If someone is breaking the rules there should indeed be a punishment but we can't have different standards for every block and sometimes even every address. There is no difference between the 1600 block of West Broad and the 2000 Block of West Broad yet the Republic had an SUP that allowed live music and a 2am closing time and there are residences above and next to what was The Republic and is now The Pig and Pearl. Emilio's has is a music centered venue that is another huge asset tot he neighborhood and they have a 2am closing time, with residences above and adjacent, AND is located on a corner. The Camel goes to great lengths to ensure music doesn't bother the neighbors, the business is appropriately operated and the owner present most of the time, but he is required to close early...it doesn't make much sense. If Mr. Burgess is allowing noise to disturb the quiet of the neighborhood I would be the first person to call him and tell him to make it
stop, and as he has exhibited in the past, he listens and comes up with strategies to fix issues. I am not suggesting we allow nonsense, just be fair and stop operating our city through squeaky wheel politics and procedures not to mention the often very personal attacks on local business owners. The most negative impact on property values in this commercial block is not The Camel, it is the many vacant buildings located in this block so let's not go backwards and put Mr. Burgess out of business and create one more empty building. Let's encourage the owners of those vacant buildings to get moving and finish the decade long renovations next door so they too are an asset to the block. 1 speak not just as the association president but also as a resident of the 2000 block and I personally back up two three immediate restaurant/night clubs, The Pig \& Pearl, The Savory Grain, and Fieldings, as well as a 4th a the other end of this block, Level. All are amazing venues for food and/or some music as well. We have gratefully had the former Julian's developed into a lovely mixed use location with Italian food and a bar option, Pane E Vino at ground level and residential space above. All good neighbors. When we have an issue with noise or trash, we address it directly with the owners and they all want to be good neighbors, just as Mr. Burgess so they address concerns immediately. The restaurants are rarely an issue, the multi-family buildings on W Grace and West Broad, chronically an issue and nobody is suggesting we put those owners out of business. There will always be a few residents that approach all change from a fearful perspective...that any change is scary and bad and I occasionally have a resident that wants boarded up buildings to remain boarded up because the idea of change is simply too overwhelming. That is no way to run a city and certainly no way to build outstanding urban neighborhoods.
Mr. Burgess has created a unique model at this location that provides a forum for local up and coming musicians to perform and is an excellent option for good food AND music for the neighborhood; many of our residents have even taken their kids and grandparents to Bluegrass Friday nights from 6-8pm as this is actually a pretty family friendly venue during the early hours. He has also received many accolades from the greater community as a venue for great music and food so he brings positive attention to the neighborhood as a whole.

The Camel is located at 1621 West Broad Street which is arguably one of the most commercial locations in Richmond city. Traffic noise will likely violate the noise ordinance most of the time as there is a bus stop at the corner here and heavy traffic pretty much 24 hours a day. The association and neighborhood would definitely draw swords over any kind of car lot, pornography or strip club but we strongly encourage positive development and well run options for the neighborhood. Mr. Burgess has never received an ABC warning much less a violation, I have received a copy of his most recent health inspection, and as an added bonus provides Richmond City with significant tax revenue at least in terms of small businesses revenue; while this isn't totally relevant to the neighborhood, definitely a nice bonus. There was an issue with his garbage cans as the unofficial Fraternity house behind The Camel does not have a single can and has been filling The Camel's cans but I have contacted James Jackson at DPW regarding this issue and he is always amazingly responsive sol am looking for this to be resolved quickly. Also, Mr. Burgess has changed to a private waste collection provider so he will have 6 cans and Monday and Friday pickup so I think the garbage issue has been addressed fully. Mr. Burgess has always supported the neighborhood and the association and we all have a vested interest in appropriately run, successful business ventures landing and staying on West Broad. Let's not put Rand out of business only to give permission to the next tenant/owner (which is a likely scenario). Let's try to create an atmosphere that leads to success for everyone!

Regarding The Camel's SUP application
I am writing in support of the requested changes to The Camel's SUP. I have spoken to those residents that back up to The Camel that are in the WGSA and there have been additional letters of support that have been sent to planning directly from those residents. After 6 months and many conversations and emails with one owner, Rex Scudder, who initially had only a couple of minor issues, not related to the SUP change that he wanted me to address with Mr. Burgess (as was done) Mr. Scudder has, in the last two weeks, decided to work with Mr. Shorkey, the owner of Fan Tan and of course he has every right to do so. On Monday May 19 ${ }^{\text {th }}$, we gave Mr. Scudder the opportunity to share his personal concerns as well as to act as agent for Mr. Shorkey at the May WGSA board meeting. Several 1600 block neighbors some of whom have offered support for The Camel's change in SUP were present as well as the always present representatives form VCU police, Greg Felton and RPD, Officer Ward Kuper. Mr. Scudder was to have 10 minutes to share and we allowed him an hour and a half but he was unable to share any compelling concerns related to the SUP change so the WGSA a second time voted to support The Camel's requested changes. Some neighboring residents have asked to speak on behalf of the Camel at the planning hearing in June. This is in no way meant to be disrespectful to Mr. Scudder, he is a good neighbor and we appreciate his input and will continue to work on other issues in tandem and on his behalf.

If we can't be flexible and fair, we will never be successful. The current SUP was crafted many years ago when most of $W$ Broad consisted of empty, derelict buildings so I understand why there were extra precautions taken. However, those days are over and the current SUP places a decidedly discriminatory and burdensome set of restrictions on Mr. Burgess that are not uniformly applied to other similar venues on West Broad Street. Some of these requirements actually pose a hazard as Mr. Burgess is required to take his patio fencing down every night so it is not secured to the ground (nobody else is required to do this). We should have a single standard for everyone that is in a like-kind location. We should enforce the rules in an equitable, uniform manner and protect every resident and business. If someone is breaking the rules there should indeed be a punishment but we can't have different standards for every block and sometimes even every address. There is no difference between the 1600 block of West Broad and the 2000 Block of West Broad yet the

Republic had an SUP that allowed live music and a 2am closing time and there are residences above and next to whal was The Republic and is now The Pig and Pearl. Emilio's Has is a music centered venue that is another huge assel tot he neighborhood and they have a 2 am closing time, with residences above and adjacent, AND is located on a corner. The Camel goes to great lengths to ensure music doesn't bother the neighbors, the business is appropriately operated and the owner present most of the lime, but he is required to close early...it doesn't make much sense. If Mr. Burgess is allowing noise to dislurb the quiet of the neighborhood I would be the first person to call him and tell him to make il stop. and as he has exhibiled in the past, he listens and comes up with strategies to fix issues. I am not suggesting we allow nonsense, just be fair and stop operating our city through squeaky wheel politics and procedures not to mention the often very personal attacks on local business owners. The most negative impact on property values in this commercial block is not The Camel, it is the many vacant buildings located in this block so let's not go backwards and put Mr. Burgess out of finish the decade long renovations next door so they too are an asset to the block. I speak not just as the association The Pig \& Pearl, The Savident of the 2000 block and I personally back up two three immediate restaurant/night clubs, venues for food and/or some music as well. We have gratefully had the former Julian's developed into a lovely mixed use location with Italian food and a bar option, Pane E Vino at ground level and residential space above. All good neighbors. When we have an issue with noise or trash, we address it directly with the owners and they all want to be good neighbors, just as Mr. Burgess so they address concerns immediately. The restaurants are rarely an issue, the multi-family buildings on W Grace and West Broad, chronically an issue and nobody is suggesting we put those owners out of business. There will always be a few residents that approach all change from a fearful perspective...that any change is scary and bad and I occasionally have a resident that wants boarded up buildings to remain boarded up because the idea of change is simply too overwhelming. That is no way to run a city and certainly no way to build outstanding urban neighborhoods.

Mr. Burgess has created a unique model at this location that provides a forum for local up and coming musicians to perform and is an excellent option for good food AND music for the neighborhood; many of our residents have even taken their kids and grandparents to Bluegrass Friday nights from 6-8pm as this is actually a pretty family friendly venue during the early hours. He has also received many accolades from the greater community as a venue for great music and food so he brings positive attention to the neighborhood as a whole.

The Camel is located at 1621 West Broad Street which is arguably one of the most commercial locations in Richmond city. Traffic noise will likely violate the noise ordinance most of the time as there is a bus stop at the corner here and heavy traffic pretty much 24 hours a day. The association and neighborhood would definitely draw swords over any kind of car lot, pornography or strip club but we strongly encourage positive development and well run options for the neighborhood. Mr. Burgess has never received an ABC warning much less a violation, I have received a copy of his most recent health inspection, and as an added bonus provides Richmond City with significant tax revenue at least in terms of small businesses revenue; while this isn't totally relevant to the neighborhood, definitely a nice bonus. There was an issue with his garbage cans as the unofficial Fraternity house behind The Camel does not have a single can and has been filling The Camel's cans but I have contacted James Jackson at DPW regarding this issue and he is always amazingly responsive so 1 am looking for this to be resolved quickly. Also, Mr. Burgess has changed to a private waste collection provider so he will have 6 cans and Monday and Friday pickup so I think the garbage issue has been addressed fully. Mr. Burgess has always supported the neighborhood and the association and we all have a vested interest in appropriately run, successful business ventures landing and staying on West Broad. Let's not put Rand out of business only to give permission to the next tenant/owner (which is a likely scenario). Let's try to create an atmosphere that leads to success for everyone!

Dear Department,
I am writing to express my support for The Camel in its request for expanded hours. The Camel and its owner, Rand Burgess, has been very good neighbors, and The Camel is the kind of restaurant/business that should be encouraged in neighborhoods like the Fan.

I live at 1624 West Grace Street. My wife and I have owned the house since 1994, and have lived there continuously since we purchased it. We are on the north side of Grace St, backing up to the same alley that runs behind The Camel. There are only 1 or 2 residential properties that can say they are closer to The Camel than mine, and even then it is a matter of a few feet. It is no more than 30 feet from my back property line to the corner of The Camel's property line.

I have a deck behind my house, from which I can see the back of The Camel. I can tell you straight up that noise from The Camel has never been a problem. Every single time I have investigated the source of music coming from behind my house in the evening, I have found that it was coming from one of the many properties on the street that rents to VCU students. While I have heard my neighbor practicing his drums next door on occasion or a group of students having a party in their yard, I have never heard a band from The Camel while sitting on my back deck in the evenings. If you visit the interior of The Camel, you will see that the stage is at the front of the building, making it even harder for music to travel out the back to the residential properties located behind.

The Camel is not just another "nightclub" with music. Rand supports the local youth music scene in ways that are healthy and good for the neighborhood. While my son was a student at Maggie Walker Governor's School, he walked back to The Camel a number of times to listen to one of the local high school bands from his school that Rand was featuring on special days. Additionally, Rand runs a first class restaurant. His menu is as far from "bar food" as you can get. By contrast he features creative food that is comparable to the best restaurants in the area.

I've known Rand for years, and live known The Camel since before it even opened to the public. His is the kind of business that the City should be encouraging to open and operate in Fan. Allowing Rand to stay open later as requested will not infringe on the quality of life of any of the residential neighbors living nearby. I encourage you to grant his request.
