PURPOSE: To amend ORD. 2023-071 by modifying the currently adopted title of the Non-Departmental line item and organization name "JWC Foundation" to "The Richmond Night Market Foundation."

BACKGROUND: The Proposed and Adopted FY24 budget document includes funding in the Non-Departmental agency in the amount of \$30,000 for the purpose of supporting local artisans and small businesses while celebrating the diversity and love of art, music, and culture in downtown Richmond. This request is for a technical fix, as it was initially indicated that "JWC Foundation" was the appropriate recipient name. Resultantly, these funds were appropriated to JWC Foundation in the approved FY24 budget. However, it has subsequently been discovered that "The Richmond Night Market Foundation" is the proper legal name and entity to steward the funds for the intended purpose. Per the advice of the City Attorney's office, and in order to ensure that the adopted funding of \$30,000 is granted to The Richmond Night Market Foundation for the adopted purpose, it is recommended to seek City Council approval to make a technical correction to Ordinance 2023-071 by modifying the listed name.
