CHAMBER EVACUATION PLAN

Council President Chris Hilbert called the meeting to order at 4:08 p.m. and presided.

PAPER FOR EXPEDITED CONSIDERATION

Councilor Andreas Addison moved to expedite consideration of the following resolution, which was seconded and approved:

RES. 2018-R101

To encourage and support participation in the "Love Lights" program for the 2018-2019 year and each year thereafter, with the display lasting through January 1, 2019, and through January 1 of each year thereafter.

President Chris Hilbert provided an introduction of RES. 2018-R101.

Councilor Michael Jones and Vice President Cynthia Newbille requested to be added as copatrons of the proposed legislation.

There were no further discussions and RES. 2018-R101 was unanimously adopted.

MOTION

Councilor Michael Jones moved that the ordinance entitled:

ORD. 2018-297

To create the Navy Hill Development Advisory Commission and announce the Council's intent to hold public hearings, all for the purpose of providing for the Council's consideration of a development proposal in the area generally bounded on the west by N. 5th St., on the north by E. Leigh St., on the east by N. 10th St., and on the south by E. Marshall St.

be amended and continued to Monday, December 10, 2018, as follows:

Page 2, Line 10

After the closing quotation marks following the semicolon after the word "Programs", insert the word "and"

Page 4, Line 13

At the beginning of the line, add the paragraph "9. **Access to Information.** It is the intent of this ordinance that the Commission have full access to all information that the Commission deems necessary to the performance of its duties under this ordinance, including, where permitted by law, information deemed confidential."

The motion was seconded and unanimously approved.
