## The Media has reported the following information.

(The citation links are given below.)

## February 20, 2017:

. . . .

"Richmond's mayor has hired a former state official who was convicted of embezzling nearly \$240,000."

## Jul. 18, 2017: (Referring to the Auditor)

"The administration wanted to get rid of Dalal because he found too much fraud and waste, embarrassing the city."

### Apr. 13, 2022:

"Messages reveal mayor's office asked Richmond auditor to change school construction cost report."

### Jul. 20, 2022:

"The city's watchdog found black holes in the record-keeping of how that money was spent."

## Aug. 29, 2022: (Regarding the collapsed Enrichmond Foundation)

"CBS 6 has reached out to RPD inquiring if any complaints have been filed but has not heard back."

## Sep. 9, 2022: (Again regarding Enrichmond)

"The city's police department did not immediately respond to a request for comment."

### Oct. 14, 2022: (Enrichmond)

"There has been nothing from the Mayor's office."

### Oct. 28, 2022: (Enrichmond)

"Richmond's commonwealth's attorney, attended the volunteers' meeting and said three community groups were in contact with a Richmond police detective."

"If there's an investigation, it's at the very beginning," she said.

She "also outlined which law enforcement agencies might be able to investigate the issue."

## Dec. 7, 2022: (Enrichmond)

"Everyone is pitching in to help — except the Mayor and the City."

## Dec. 23. 2022: (Enrichmond)

"They have also pleaded their case to the Richmond Police Department, City of Richmond, Richmond Commonwealth's Attorney, and other agencies. So far, there has been no visible progress toward a just resolution."

## Jan. 26, 2023: (Enrichmond)

A citizen "said he and a few other former Enrichmond partners had brief conversations with a Richmond detective, "but his position was that there was no evidence of a crime, and without some evidence he could not investigate.

#### Jan. 13, 2023:

"The city legally cannot pursue the Enrichmond Foundation in a court of law, because we have not given money to the Enrichmond Foundation for two years," said a Councilmember.

A citizen "said they had spoken to the Richmond Police Department (RPD), but were told there was no evidence of a crime and it could not be investigated... CBS 6 has reached out to RPD for comment on this."

#### Feb. 13, 2023:

"The local commonwealth's attorney told us they were waiting for an investigation by law enforcement before deciding whether any action could be taken. But neither Richmond nor state police are currently investigating."

## Mar. 23, 2023:

A City Hall official "said the City Attorney's Office has determined that because no city funds were involved, the city had no legal right to sue..."

"The Richmond Police Department and Commonwealth's Attorney's Office have found no evidence that embezzlement or other criminal activity was involved in the loss, and have deemed it a civil matter."

## Apr. 4, 2023:

The Mayor... "But though he said the city would assist in that investigation, he added they had no plans to strengthen their own oversight of organizations like Enrichmond."

"It's not the city's role to oversee non-profits. At the end of the day, that's the Office of the Attorney General," he said.

## May 17, 2023:

"8News previously reported that the Richmond Police Department (RPD) was looking into the dissolution, with Richmond City Commonwealth's Attorney... confirming that her office was waiting on information from RPD "to see if charges were appropriate."

"The Office of the Attorney General (OAG) and Federal Bureau of Investigation (FBI) have since begun investigating the foundation's sudden collapse."

## July 19, 2023: (Fraud at Dept. Public Works)

"A former Richmond Department of Public Works official and his wife pleaded guilty Wednesday to defrauding the city..."

"The Department of Justice says from at least 2016 through 2021, Michael and Samaria took steps to defraud the DPW. Samaria and other co-conspirators first created and operated straw companies to bid on DPW work."

Aug. 11, 2023: (Towing case, 19 counts of Grand Larceny of a Motor Vehicle, according to court records)

"...Richmond Police... served a search warrant at No Limit Towing... in a fraud and motor vehicle theft investigation."

(Video - Minute 1:15) "Most of our officers, before they knew what was going on, thought that this is just a civil matter, you guys work it out in the courts."

## Aug. 18, 2023: (Grand Larceny of a Motor Vehicle)

"Sherral Crawley... [was] arraigned on... motor vehicle theft... When asked by the judge if she had an attorney... [the attorney]... told her... that this was a civil matter..."

## Aug. 18, 2023: (Grand Larceny of a Motor Vehicle)

Sherral Crawley... "said the lawyer... said her case should be a civil matter....."

"Diggs... says he tried to go to police but was told it was a civil matter..."

"Now, it is a criminal case."

"Police thought that there was a possibility that it was simply a civil infraction. And after speaking with them, it was very clear there was some malicious intent involved," Richmond Police Sargeant Nicholas Castrinos said.

## Sept. 5, 2023: (Grand Larceny of a Motor Vehicle)

"The Richmond Police Department's message has remained consistent since this story first broke. The department has continued to ask anyone who believes they might have been victims to file a police report and contact Richmond Police Detective Sergeant Castrinos at 804-646-1144..."

"Our team also asked police if there was any way victims could get their money back. Police remained vague in their response as this matter continues to be under investigation, but they did reiterate that this investigation has elements of both criminal and civil violations..."

"Police said that — as with any civil matter — victims should follow processes in place like contacting attorneys and "availing themselves of the court system for relief."

## Oct. 23, 2023: (Meanwhile, Harrisonburg knows how to prosecute embezzlement.)

"In a Harrisonburg White Collar Crime Case.."

"The Circuit Court sentenced Hahn to 20 years on each embezzlement count..."

"Office of Attorney... assisted in the investigation of the case with the Harrisonburg Police Department and Rockingham County Commonwealth Attorney."

## Oct. 24, 2023: (Also Harrisonburg embezzlement)

"Offender in embezzlement, money laundering case sentenced to 15 years."

"... Several law enforcement agencies, including the Winchester Police Department, Homeland Security Investigations and Frederick County Sheriff's Office, all assisted in the investigation, and investigators from the Office of the Attorney General of Virginia partnered with HPD detectives throughout the process."

## Dec. 7, 2023: (Update on Public Works case)

"Woman says former executive who defrauded city also fooled her."

"The Free Press was told that DPW employees who knew what was happening kept silent after finding the department fired people who talked about the misdeeds of senior department executives."

Mar 1, 2024: (Meanwhile, Henrico knows how to investigate and prosecute embezzlement in a nonprofit case.)

"Former Henrico youth baseball president sentenced to 20 years for embezzlement."

"According to evidence from the Henrico Commonwealth's Attorney's investigation, McCook used the baseball team's debit card over 70 times between 2020 and 2021. He also made large withdraws from the team's account, which added to more than \$26,000."

## Apr 01, 2024: (Car Thefts)

. . . .

"Car thefts are skyrocketing in Richmond, but cases are rarely getting solved"

## Apr 11, 2024: (Enrichmond)

"They lost thousands when EnRichmond collapsed. Now they're learning no one will be prosecuted."

"A spokesperson for the Justice Department declined to comment on why they decided not to press charges."

**Purpose: Written Public Comment** 

I am expressing my views in writing in addition to an oral 3-minute presentation for a matter of Public Record today at the Public Safety Meeting of City Council on June 25, 2024.

## 3-Minute Speech

I come here today to challenge you to "Reach for the Stars!" which is the motto on Richmond's *Seal* and contains the <u>symbol of justice</u>.

When we see Richmond's Seal, we expect to see *legitimate*Justice.

The City of Richmond, has a "constitutional duty to take care that the laws be faithfully executed"; and, to administer justice.

Having said that, the Media has reported some *interesting* comments relating to our city's <u>"Star"</u> Leaders.

I hope the following information will inspire city leaders to work hard to make citizens proud and welcome Richmond's Seal as a symbol of *embracing justice*, and <u>not</u> a symbol of *deprivation of rights*.

Richmond's mayor Levar Stoney hired a former state official who was convicted of **embezzling**. (Does the Mayor sound like a "star" leader?)

City Council Members say that when *Nonprofits embezzle* in Richmond, the police are to treat the <u>crime</u> as a "Civil Matter". (Does this inspire confidence in our city or our "star' leaders?)

A Richmond Commonwealth Attorney says that § 18.2 – 111 Embezzlement deemed larceny is a "Civil Matter" when <u>Nonprofits</u> commit the <u>crime of embezzlement</u>.

A clerk of the court says that the Commonwealth's Office does not "do" Nonprofit embezzlement.

Richmond detective asserts that RPD *purposely* trains officers *incorrectly* in the academy to say that Nonprofit embezzlement is a "Civil Matter".

Erroneously, RPD officers, detectives, sergeants, captains, and majors say that the crime of embezzlement § 18.2 – 111 is a "Civil Matter" if the crime happens within a Nonprofit.

Mistakenly, RPD dispatch tells victims of embezzlement that it's a "Civil Matter" if the perpetrator is the president of a Nonprofit.

RPD has also told victims of grand-theft-auto and extortion that it is **their problem**. Chief Edwards said, "Most of our officers, before they knew what was going on, **thought** that this is just a "civil matter".

The Property Crimes guy, Sergeant Castrinos, said that there are over 1,000 entries in the police department's system which are related to the *illegal towing*. He said, "Police thought that there was a possibility that it was simply a *civil infraction*".

Citizens have been victims of tow-truck companies stealing cars for over 20 years and RPD is just realizing that it's a <u>crime</u> to steal cars?! (Does this inspire confidence in our city <u>or</u> our <u>"star"</u> leaders?)

I challenge our leaders to put a stop to the obstruction of justice that is taking place under the color of law, but instead reach for the stars, *administer justice*, and make Richmond shine again.

## **Powers of Investigation by City Council Members**

## § 4.16. - Powers of investigation.

(a) The council, or any committee of members of the council when authorized by the council, shall have power to make such investigations relating to the municipal affairs of the city as it may deem necessary, and shall have power to investigate any or all departments, boards, commissions, offices and agencies of the city government and any officer or employee of the city, concerning the performance of their duties and functions and use of property of the city.

Today I am formally requesting, again, that this Council use their powers of investigation that are granted to them under these codes to figure out why Law Enforcement is lying to citizens and thereby helping the criminals get away with such crimes as grand larceny and arson.

So, will you obey the law and report Law Enforcements misconduct and bring honor to the citizens by launching an investigation?

Lasty, the Virginia Constitution says in Article V, Section 7 that the Governor shall enforce the execution of the laws, so if you need back up then I suggest that you give him a ring.

## Thoughts...

City Council has a responsibility under the VA Municipal Code to report misconduct that they are aware of within the Police Department and the Commonwealth's Office.

This Council has been made aware that Law Enforcement is lying to citizens by saying that crimes are a "civil matter". Citizens have also been told by Law Enforcement when they have their cars stolen that "it's just kids"; implying that

the victim won't get justice for the crime of grand larceny. Victims of grand-theftauto are being told that it's a "civil matter". (tow-truck company scheme)

## **Richmond Virginia Municipal Code**

Sec. 2-161. - Procedure for disclosure.

(a) City employees are responsible for reporting instances of misconduct, including fraud, waste and abuse. An employee shall disclose all relevant information regarding evidenced misconduct to the Inspector General or the designee thereof within one month of the day on which he knew or reasonably should have known of the misconduct. He may contact the Office of the Inspector General by way of the hot line, through the Inspector General's website, in writing or in person. The Inspector General shall publicize the means by which employees may disclose information pursuant to this section.

Civil Law Basics What is civil law?

Civil law is the term used to describe non-criminal law having to do with private rights and remedies related to property, commerce, and administrative matters.

Someone who violates a criminal law may be jailed, fined, or placed on probation.

Someone who is liable under civil law may be ordered by a court to pay a sum of money to another person or to take some other action to remedy a problem.

It is possible for a person to be charged with a crime and be held liable for damages under civil law for the same act. For example, someone who attacks another person may be charged criminally with assault and battery. However, the victim may also pursue the matter civilly to be paid for damages related to the attack such as broken glasses, medical bills, and lost wages.

He was also ordered to pay \$150 per month in an effort to pay back the \$239,000 he took.

Since 2017, with the assistance of a state foundation, Enrichmond has taken ownership of the long-neglected Evergreen and East End cemeteries that straddle the Richmond-Henrico County border near Oakwood Cemetery.

The foundation has received small amounts of city funding, but largely has been self-supporting and independent in operation.

The foundation appears to have last filed a required financial statement with the Internal Revenue Service in 2019

John Sydnor, who served 11 years as Enrichmond's executive director, left the organization last year.

The chair of City Council's Education and Human Services Committee plans to seek a financial audit of the collapsed Enrichmond Foundation, which previously played a crucial role in providing support for city parks and recreation.

Fifth District Council woman Stephanie A. Lynch issued the statement in the wake of a Free Press article last week reporting on the sudden and unexpected demise of the independent foundation after 32 years.

Ms. Lynch said the closure has left in the lurch dozens of civic associations, parks and other recreation-related organizations that relied on the nonprofit to be their fiscal agent. "None of my neighborhood associations or nonprofits can access their money," she stated.

Such groups "are the backbone of this city," Ms. Lynch continued. "The trust between these groups and Enrichmond has been broken.

"We need to do everything in our power to protect these group's civic assets as well as hold Enrichmond accountable," she said. "We need to conduct a thorough audit and get a handle on how these groups can be made whole" financially.

As reported last week, the foundation's board has resigned, its staff has been laid off and its bank account apparently has been depleted. The foundation's website also has been shut down, although the Facebook page is still accessible.

On Tuesday an attorney for the foundation, Kerry B. Hutcherson, confirmed in an email distributed to representatives of its partner organization, that the organization is taking legal steps to dissolve.

The foundation's collapse also is raising concern about the operation and maintenance of two historic Black cemeteries it owns, Evergreen and East End, located adjacent to Oakwood Cemetery.

Those cemeteries are to become the property of the Richmond Department of Parks, Recreation and Community Facilities after the foundation is dissolved, according to the foundation's charter.

Ms. Lynch stated that she hopes to get more information from Mayor Levar M. Stoney's administration at the next meeting of her committee scheduled for Thursday, July 14.

In addition, she plans to request that the full council authorize the city's auditor to undertake the financial investigation.

The foundation appears to have no direct ties to the city, which apparently did not have a role in appointing board members or hiring staff. The Stoney administration, including the mayor's office and Christopher Frelke, director of Parks, Recreation and Community Facilities, has not responded to Free Press requests for information on Enrichmond.

Commonwealth's Attorney Colette W. McEachin, responding to a Free Press query Tuesday, stated that her office has not been asked to investigate as there has "been no specific allegation of criminal conduct by or against any person." She stated that makes it a civil matter.

RICHMOND, Va. -- Millions of federal dollars flowed into the City of Richmond during the beginning of the COVID-19 pandemic to help those who were struggling. Nearly two years later, the city's watchdog found black holes in the record-keeping of how that money was spent.

The city received about \$40 million in CARES Act funding in the summer of 2020 which was meant to serve as immediate aid for impacted Richmonders. By December 2020, the city had already gone through 94% of it...

4th District Council Member Kristen Nye, who sits on the audit committee, said the council and the mayor directed the city auditor, Lou Lassiter, to investigate how the money was spent in Richmond to catch any issues before having to file reports with the federal government.

"The whole purpose of doing the audit is not to do a 'gotcha.' It's more to find the holes in government and to make sure that as we move forward, that they're fixed," Nye said.

After reviewing the completed audit, Nye said she was concerned about gaps in cash distribution and that most of the issues listed in the audit involved the Office of Community Wealth Building, the city department which addresses poverty.

"Since then, there's been a change in leadership in that office, as well as some internal controls that have been put together," Nye said. "I personally will be monitoring that department."

Lassiter found issues in the following areas:

Staff members who processed assistance for businesses and non-profits also participated in the screening and approval of applications. Lassiter also said he could not determine if \$50,000 in business aid was spent allowably due to a lack of documentation of how the money was spent.

The city did a poor job keeping records of more than \$1 million worth of gift cards distributed to citizens. The auditor couldn't account for potentially dozens of cards that could total up to \$44,000.

"My biggest concerns came from the items that were related to cash, like gift cards that were distributed. There were definitely some holes in tracking who received them," Nye said.

Mayor Levar Stoney agreed with the auditor that the city hall has room for improvement in money management.

"I think it comes down to better bookkeeping, right? And so more training on how we go about bookkeeping to make sure we can keep track of those dollars," Mayor Stoney said.

The mayor also defended the work of essential employees during the peak of the crisis.

"Remember, this was an emergency situation. And local government, that's where the rubber meets the road. We had to step in right away, make sure folks stayed in their homes, make sure folks got fed, and we did exactly that," Stoney said.

Lassiter made eight recommendations in which city departments can better document and manage funds in the future. He also suggested the city eliminate the use of gift cards for assistance moving forward.

All recommendations were accepted by city hall leaders, and Nye said she will make sure each change is met by the deadlines set forth by Lassiter.

"It's really important as we continue to take these ARPA [American Rescue Plan Act] dollars from the federal government that we are spending them wisely and that there is accountability for all those dollars," Nye said.

"The frustration on the time it is taken to get clarity around these answers is real, it's palpable, I'm also equally as frustrated, I think, you know, the members of the organizations, the administration, I mean, all of us want to get to the bottom of it as quickly as we can and find resolve," said Lynch. "There's several options on the table, none of which seem to be great options...

One, having the community groups file, as individuals, with the Richmond Police Department and launch an investigation into the organization for potential fraud and embezzlement.

Two, in parallel to that, the city is exploring what options it has to start a civil suit.

And then there's been discussion around what powers or purview does the attorney general's office have over nonprofit organizations."

News of Lynch's call for criminal complaints was first reported by the Richmond Free Press.

CBS 6 has reached out to RPD inquiring if any complaints have been filed but has not heard back.

CBS 6 has also reached out to the Virginia Attorney General's office asking if they have been asked or are considering an investigation, but have not heard back.

Suddenly in June, the Foundation announced a cessation of operations, leaving no transition plan. The Board voted to dissolve the Foundation but left no accounting of the funds it had in its accounts, and then within weeks the lawyer representing the Board stepped away from his role as counsel.

None of the "leaders" at City Hall has said anything about this. Not. A. Word.

City's lack of action

There are only two entities currently with a claim to file receivership for Enrichmond's assets: a bank, which is an outstanding creditor, and the City. Essentially, the first to file for receivership would control the process that is driven by the courts. The court-appointed receiver could sell the land or assets to recoup its costs.

According to my sources, Enrichmond has asked the City to initiate the receivership filing with the court and, as mentioned, the City has standing because it is owed money. The receivership process is not particularly complicated, but the City has made it known that it does not want to address this in a quick time frame — perhaps six months from now, in the summer of 2023 — maybe.

Everyone is pitching in to help — except the Mayor and the City.

## A Controversial Virginia Nonprofit Collapses, Leaving Questions and Anger

After Enrichmond's implosion, members of some of these groups formed the Enrichmond Accountability Project (EAP) to try to claw back their money. They have also pleaded their case to the Richmond Police Department, City of Richmond, Richmond Commonwealth's Attorney, and other agencies. So far, there has been no visible progress toward a just resolution.

Recently, EAP started working with an advocate from the nonprofit sector to secure pro bono legal assistance. "It seems like litigation may be the only option, since the city council is no longer willing or able to take responsibility," said Mac Wood of EAP and Friends of Pump House, a former Enrichmond community partner. "I would love to settle outside of court, but the silence from Enrichmond's board and the City of Richmond is leaving us with few options," Wood said.

Parity, "c/o Enrichmond Foundation," still owns East End and Evergreen. Enrichmond's executive director, John Sydnor, was Parity's only "sole member-manager."

"All digital repositories were lost (as far as I know)," the consultant Enrichmond hired to lead the project wrote on her blog. "Files, electronics, and historic documents stored in the company office are in the hands of some unknown person. Everything that people had been working on since 2017, vanished."

After a year of seeking assistance and a path forward, it has become apparent that the situation is much too complicated for a volunteer board to resolve. The majority of the volunteer board submitted final resignations.

"You need that police power, you need the subpoena power, you need to be able to get their records," Schmidt explains.

The local commonwealth's attorney told us they were waiting for an investigation by law enforcement before deciding whether any action could be taken. But neither Richmond nor state police are currently investigating.

Schmidt says the best person for the job is the state Attorney General – who has authority over nonprofit fraud and access to state police resources.

"The Attorney General today could assign an assistant attorney general and call up the state police and say, 'Let's go subpoena all of these records and get to the bottom of this.' And that is really where the ultimate authority, I think, and the ultimate responsibility lands," Schmidt says.

A spokesman for the state attorney general says they haven't received a formal complaint, but that the office stands ready to take action where appropriate.

City Hall is a \$3 billion yearly operation with a lot of moving parts and thousands of employees.

Given that the city operates with taxpayers' money, there is a need for attention to detail to ensure that the money is well spent and the reason why there is an internal auditor and an inspector general to look into the conduct of city business.

Two recent examples suggest that city officials are often less than attentive.

In the past week, two former employees of the Department of Public Works were sentenced to prison terms after they pleaded guilty to ripping off the department for more than \$600,000 over at least a five-year period.

One was Michael Evins, the now retired director of DPW operations.

He created phony companies with his wife, Samaria Evins, who was listed as the owner-operator.

He then directed phony contracts to those companies with the assistance of a DPW technician, Shaun Lindsey, who was empowered to select vendors for smaller contracts. Invoices were then sent to the Department of Finance even though Mrs. Evins' companies never did any work. The conspirators got away with it until the inspector general, James Osuna, got a tip, investigated and brought in the federal government to assist in holding the trio accountable for one of the biggest efforts in city history to enrich themselves at taxpayers' expense.

As it turns out, the scheme worked because neither City Council nor the executives working under Mayor Levar M. Stoney have required each department to have internal controls, essentially practices that ensure that one person is not allowed free rein to do as they please.

The U.S. military is a far larger operation than the city, but the Pentagon has internal controls in every element of the military.

Each section with a budget must submit an internal controls report, signed off on by a ranking officer, to the inspector general's office so that the spending can be checked and verified as proper.

In Richmond, the three conspirators got away with \$600,000, not a lot of money for the city when

spread over five years when more than \$10 billion would have sloshed through city coffers.

Still, there does not seem to be a good reason why controls are not in place to prevent another Michael Evins from operating without any attention from his bosses or anyone else.

Another example of a lack of city oversight involves the distribution of grants to largely volunteer community organizations that lost money when the city-created but independent Enrichmond Foundation collapsed in 2022.

The city, with council approval, in July provided \$250,000 to The Community Foundation, which set up the five-member Richmond Outdoor and Prosperity Fund Committee (ROPFC) to divvy it up for the groups.

The \$250,000 might just be a token. The total money that disappeared is still unknown. The Stoney administration originally estimated the loss that more than 80 groups experienced total around \$250,000 to \$300,000, but other estimates have suggested the total loss was up to 10 times as much

A state and federal investigation into the loss was started earlier this year.

However, with no one at the city or on the council paying attention, ROPFC decided it could do what it wanted with the money

Even though the council approved the \$250,000 to be used to reimburse the organizations for losses, the ROPFC refused to do so.

Instead, the ROPFC, led by Kelly Chopus, determined without any consultation with the council that it would award the money to applying groups only for new projects, the Free Press has been told.

Last week, the ROPFC reported to a council committee that it had awarded 19 organizations a total of \$140,895 or an average of \$7,416 apiece, with the remaining \$109,105 to be distributed in 2024 in a second round of grants.

To add insult to injury, the ROPFC did not even bother in its report to list the groups that got the money and the purpose for which each grant is

Just as bothersome, Ms. Chopus and other members decided to cut out the Free Press, which broke the story of the foundation's collapse. Ms. Chopus and other committee members have not been available for comment, and The Community Foundation also did not respond to a request for comment on the ROPFC's practices and decisions.

The ROPFC stated in its report to council's Education and Human Services Committee that Matt Leighty, an ROPFC member, was to issue a press release about the grants. But the Free Press has received no such release.

But this is taxpayer money, not The Community Foundation's nor the ROPFC's.

It remains unexplained why such or any group, no matter how reputable, would be allowed to use city money without being required to detail that use in a report that is open to the public.

More attention to detail, please.

#### Mar. 1, 2024 Henrico baseball president - embezzlement

Former Henrico youth baseball president sentenced to 20 years for embezzlement Mar 1, 2024

HENRICO COUNTY, Va. (WRIC) — The former president of Lakeside Youth Baseball League was sentenced to 20 years in prison for reported embezzlement from the team.

On Friday, March 1, Christopher McCook, the former president of Lakeside Youth Baseball League was sentenced to 20 years in prison for two embezzlement charges, but will serve only three years and six months behind bars.

According to evidence from the Henrico Commonwealth's Attorney's investigation, McCook used the baseball team's debit card over 70 times between 2020 and 2021. He also made large withdraws from the team's account, which added to more than \$26,000.

In January, McCook filed a motion to withdraw his guilty plea to embezzling thousands of dollars from the team, however, the court ultimately denied the motion.

McCook received 10 years in prison for a first embezzlement charge with eight years and six months suspended, and 10 years for a second embezzlement charge with eight years suspended. He will be under supervised probation for five years once released on both charges.

#### April 11, 2024 EnRichmond will not be prosecuted

They lost thousands when EnRichmond collapsed. Now they're learning no one will be prosecuted.

RICHMOND, Va. -- The U.S. Attorney's Office for the Eastern District of Virginia declined to prosecute anyone related to the collapse of the EnRichmond Foundation, according to the Acting Public Affairs Specialist for the FBI Richmond Leslie Chappell McLane.

McLane said the FBI's Richmond bureau turned over its investigation findings to the Justice Department.

A spokesperson for the Justice Department declined to comment on why they decided not to press charges.

Eighty-six non-profit partner groups housed their money with EnRichmond before its collapse.

EnRichmond acted as an umbrella organization and allowed the groups to be tax-exempt and fundraise as a non-profit.

When EnRichmond dissolved, the partner groups were unable to access nearly \$500,000 of their money.

One of those groups, the Richmond Tree Stewards, lost thousands of dollars.

"We had \$29,000 in our account, \$15,000 of which had been deposited just in the months before EnRichmond closed down," Dana Marshall, President of the Richmond Tree Stewards, said.

EnRichmond partner handbooks reviewed by CBS 6 explicitly said partner funds were not to be commingled with general EnRichmond funds and could not be used for anything other than their intended purpose.

But, according to internal emails reviewed by CBS 6, EnRichmond had commingled the money for years and used partner dollars to make up deficits.

"It's infuriating," Marshall said. "Very clearly lines were crossed."

Both the FBI's Richmond bureau and the Virginia Attorney General's Office launched investigations after the collapse, but a spokesperson for the AG's office said when the FBI took over the AG's office just ended up assisting the FBI and did not do a separate investigation. "We are disappointed. We would have liked to have seen accountability," Marshall said about the Justice Department's decision not to prosecute.

CBS 6 has tried multiple times over the past year to contact the long-time Executive Director of EnRichmond John Sydnor, as well as the Finance Manager, Beth Captain, to ask them questions about the missing money, but we have not heard back. At this point, Marshall said the Richmond Tree Stewards are cutting their losses and moving forward.

"We've moved on, and we are still here to do good works for the city," Marshall said.
