RE: To amend the FY2021 Capital Budget to modify the Heritage Center/Lumpkin's Jail (Devil's Half Acre) project in the Economic & Community Development Category to provide that such project include the acquisition of 1305 North 5th Street due to its historical significance associated with its use as the Burial Grounds for Free People of Colour and Slaves, the design of and improvements to the Richmond Slave Trail and Trail Head at Ancarrow's Landing and its extension to 1305 North 5th Street, and the planning activities for Shockoe Bottom and the proposed Heritage Campus.

REASON: An ordinance is necessary to amend the Capital Budget in order to provide that the Heritage Center/Lumpkin's Jail (Devil's Half Acre) project includes, and the funding appropriated for such project may be utilized for, such purposes listed above.

RECOMMENDATION: The City Administration recommends approval.

BACKGROUND: The general purpose of these funds is to honor the history of enslaved Africans in the City of Richmond. Prior to 2016, the Heritage Center/Lumpkin's Jail/Devil's Half Acre requests included funds for the Slave Trail. The requested clarification of funding purposes is in keeping with the past uses of these funds. Thus, this amendment is to allow funds for the acquisition of the Burial Ground for Free Persons of Colour and Slaves which is of critical importance. The property, located at 1305 North 5th Street (N0000233006), has a current assessed value of \$145,000, is tax delinquent, and scheduled for auction. (Va. Code 58.1-3970 grants the City the authority to purchase the property at tax sale auction and a companion ordinance for Council to authorize the City's acquisition of the parcel will be introduced alongside this CIP ordinance.) This property was used as the burial site for Richmond's black population from 1816 to 1879 and it is believed that as many as 21,000 souls may have been buried in this cemetery. The property has been extensively desecrated over the years by the construction of roads, railroads, highways, and municipal buildings. It is also from this site that many of the remains found in the VCU well originated. Today, a billboard and the shell of a small gas station (vacant for many years) stand on the property, which in no measure resembles a cemetery or sacred space. This amendment is also to allow the use of these funds to complete the design and construction of proposed improvements to the Slave Trail. (The General Assembly set aside a \$1 million reimbursement for these expenses.) The amendment will also allow for the use of these funds for the Shockoe small area plan.
