Call to Order

Council President Cynthia Newbille called the meeting to order at 6:08 p.m., and presided.

Ms. Brown-Harris also stated that she did not believe sufficient wrap-around services were in place to assist with the development.

Rachel Hefner spoke in support of ORD. 2025-048, and she stated that people need a safe place to rehabilitate.

Councilor Kenya Gibson stated her concerns about the proposed development's rehabilitation methods. Councilor Gibson also stated that surrounding neighbors had informed her of concerns about the development's impact on public safety.

Vice President Katherine Jordan stated her concerns about the proposed development's rehabilitation methods. Vice President Jordan also stated she did not believe that the proposed development provided necessary access to a supportive community.
