Equitable Affordable Housing Bond Program Follow-Up

Sabrina Joy-Hogg, deputy chief administrative officer – Finance and Administration, provided Council with an update regarding the equitable affordable housing bond program and stated that additional information will be presented in February during the Finance and Economic Development Standing Committee meeting and an affordable housing strategies work session.

2023 Annual Comprehensive Financial Report (ACFR) Update

Chief Administrative Officer Lincoln Saunders informed Council that the 2023 annual comprehensive financial report update will be presented in January.

Closed Session

At 3:18 p.m., Councilor Cynthia Newbille moved that the Council go into a closed meeting (i) pursuant to subdivision (A)(1) of section 2.2-3711 of the Virginia Freedom of Information Act to discuss and consider the assignment, performance, and salaries of certain Council liaisons, (ii) pursuant to subdivision (A)(8) of section 2.2-3711 of the Virginia Freedom of Information Act to consult with legal counsel retained by the public body regarding collective bargaining requiring the provision of legal advice by such counsel, and (iii) pursuant to subdivision (A)(29) of section 2.2-3711 of the Virginia Freedom of Information Act to discuss the terms and scope of a public contract involving the expenditure of public funds regarding the Diamond District development project in the city where discussion in an open session would adversely affect the bargaining position or negotiating strategy of the City.
