THE CITY OF RICHMOND HEREBY ORDAINS:

§ 1. **Designation of Street Block for Honorary Name.** The 1000 block of East Clay Street shall be designated in honor of Bill Martin, pursuant to this ordinance.

§ 2. **Effect of Designation.** The designation of the street block made pursuant to this ordinance shall be honorary only, shall not replace the existing name of the street, and shall have no effect on the address of any property with an address on the designated street block. The sole effect of designation pursuant to this ordinance shall be to authorize the placement of commemorative signs in accordance with this ordinance memorializing the designation in honor of the named person.



§ 3. **Administration of Ordinance.** The Department of Public Works shall implement this ordinance by installing, as soon as practicable after the adoption of this ordinance, and maintaining commemorative signs in accordance with this section. The commemorative signs shall be clearly distinct from the street signs used to identify the street block in question such that a reasonable person could not conclude that the commemorative signs reflect the actual name of the street. The commemorative signs (i) shall be affixed to a sign pole installed at each end of the block designated in section 1 of this ordinance for the purpose of fulfilling the requirements of this section or to any existing sign identifying the road designated in section 1 of this ordinance located at each end of the block designated in section 1 of this ordinance and (ii) shall bear the name of the person set forth in section 1 of this ordinance.

§ 4. **Effective Date.** This ordinance shall be in force and effect upon adoption.

PURPOSE: To designate the 1000 block of E. Clay Street, in honor of Bill Martin.

BACKGROUND:

William “Bill” J. Martin, long-time Director of the Valentine Museum, came to Richmond in 1994 to work at the Valentine after the institution experienced failed expansion at Valentine Riverside (now the American Civil War Museum). Martin invested his time and talents in revitalizing the Valentine and was named director just a year later in 1995. He elevated untold stories that spoke of Richmond’s history in a way that represented *all* Richmonders.

During his tenure at the Valentine Museum, Martin cultivated numerous community history series like Controversy/History and Richmond History tours. He championed the Richmond History Makers award program, facilitated renovations of the campus, fostered deeper collaboration with Richmond Regional Tourism, and advocated for downtown growth. Aside from his work at the Valentine, Martin was an advocate of the LGBTQ+ community, a lover of the Richmond arts scene, and at his core, a storyteller.

An honorary street sign will not only commemorate Martin’s contributions to Richmond but also highlights the importance of storytelling through community voices.

COMMUNITY ENGAGEMENT: Bill Martin was nominated by Brantley Tyndall at Sportsbackers and Meg Hughes, Acting Director of the Valentine Museum. In addition, Historic Richmond and VCU Health have written letters of support.

Nomination Form

Nomination Overview

Richmond City Council may designate city streets with honorary street signs to celebrate and memorialize individuals that were a resident of the City of Richmond, Virginia for a significant period of their life.

Nominees are considered based on their historical or cultural significance, including any significant contributions to the Richmond community.

Establishing and dedicating a Richmond City Council Honorary Street Name in a person's name is a rare, limited, and extremely high honor that may be considered and bestowed on Richmond residents. Keeping the official city street name, an Honorary Street Name includes producing, preparing, and installing a specially created sign with an honoree's name on it and installing it at the location designated for commemoration.

Nomination Process

Richmond residents, community organizations, and others interested in nominating a person to be a recipient of a Richmond City Council Honorary Street Name are welcomed to submit them for Richmond City Council consideration.

The nomination process includes completing the Richmond City Council Honorary Street Name Nomination Form and sending it to a Councilmember. It is recommended that a completed nomination, including all associated documents, **be sent directly to the Councilmember representing the Richmond Voter District containing the proposed location.**

The Councilmember may further research, consider, and vet a nomination in determining a proposal of legislation or formal Richmond City Council deliberation or action.

Guiding Legislation

Richmond City Council legislation guiding the Richmond City Council Honorary Street Name process was established by Richmond City Council Resolution # 2025-R016 and includes some of the following:

- Nominations must be for individuals, who may be alive or dead, but must have been a resident of the City of Richmond for a significant period of their life.
- Nominations are to include written documentation of the nominated individual's connection to the City of Richmond, Virginia, a description of their qualifications for receiving such an honor, and a letter from a local civic association, if applicable.
- Nominees are considered based on their historical or cultural significance, including any significant contributions to the Richmond community.
- Please see the Council resolution for more information regarding policies, etc.

**Honorary Street Renaming – Clay Street between 10th and 11th Street
in honor of Bill Martin**

Ladies and Gentlemen,

It is my pleasure to strongly support the renaming of Clay Street between 10th and 11th Streets in honor of William J. Martin. William J. Martin, affectionately known as Bill, served the Richmond community for many years as Director of The Valentine.

I have served as the Executive Director of Historic Richmond Foundation for more than 11 years. Historic Richmond a nonprofit whose mission is to shape the future of Richmond by preserving our diverse historic buildings, neighborhoods, and places, sparking revitalization, and championing our distinctive architectural legacy. Bill and I have been friends and colleagues for more than a decade, during which time I have worked closely with him in his capacity as Director of The Valentine.

Bill's legacy at The Valentine is reflected in many ways, including: groundbreaking community history series like Controversy/History and Richmond History Tours; the Richmond History Makers award program; major renovations of the entire museum campus; taking over responsibility for the First Freedom Center and expanded programming on religious freedom; a comprehensive collection refinement effort that prepared it for future collecting; and opening the museum as an official Richmond Region Tourism Visitor Center. Bill's leadership at The Valentine focused on collaborative cooperation and partnerships with countless local organizations and institutions.

Bill served as friend, partner and mentor to local museums and arts and cultural institutions, as well as to many business, civic and community leaders. Throughout his career in Richmond, with his wit and wisdom, energy and enthusiasm, curiosity and compassion, and his focus on sharing forgotten stories of people and place, Bill demonstrated on a daily basis his love for Richmond and passion for the revitalization of Downtown Richmond.

Building on history

His work focused on the entire community of Richmond, but the institution he led calls Clay Street home. It is on Clay Street that Bill's presence is most felt. He remade The Valentine into the tremendously important institution that it is today. Through his work at The Valentine's home on Clay Street, he helped us to understand where we came from, who we are, and where we are going. He helped to tell the stories about our past that were hard to tell and sometimes even harder to hear – as well as the stories that were fun and just a little bit irreverent. He was a huge champion of the Court End neighborhood and Downtown Richmond and understood that it was the beating heart of the region and that we, as a community, needed to invest the resources into its care and maintenance.

As a community, we will miss his visionary leadership, his reasoned and thoughtful voice, his gregarious spirit of fun and adventure, his entertaining anecdotes, his warm laugh, his sense of humor, and his willingness to roll up his sleeves and set to work to help the community better understand its history.

Through his work he demonstrated not only a commitment to excellence, but also made truly significant contributions to the City of Richmond. For all these reasons, I could not think of a better candidate for an honorary street renaming than Bill Martin and no street better for it than Clay Street between 10th and 11th Street.
